I, Sri Suman Sarkar , S/O- Late Sunil Kumar sarkar Assistant Engineer & Station Manager ,WBSEDCL, Siliguri Town CCC under P.S. Siliguri empowered by the Electricity Act 2003 (Amendment Act 2007) do hereby lodged this complaint against Sri Amit Goyal ,S/O Bal Krishna Goyal ,Seth Srilal Market near MAA Kali Hotel ,Siliguri,Darjeeling for committing unauthorized use of electric connection U/S 135 1(e) of the Electricity Act read with Amendment Act 2007 as stated here under.

On 07.11.2022 at about 01.40 PM , Sri Suman sarkar alongwith Sri A. Mahandeo ,D.E. (S & LP) Pranab Sikhder SO (S & LP) ,Sri Sourav Bhattacharya ,Sr. O.E. ,Rajesh Kumar singh ,Sr. T.S.H. Siliguri Town CCC Conducted one surprise checking premises at Sri Amit Goyal ,S/O Bal Krishna Goyal ,Seth Srilal Market near MAA Kali Hotel ,Siliguri,Darjeeling

During inspection offence U/S 135 1(e) of the Electricity Act was detected. The accused person at Sri Amit Goyal ,S/O Bal Krishna Goyal was using electric power for construction purpose from LT service Meter No SF609919 which is issued for domestic purpose premises at Seth Srilal Market near MAA Kali Hotel ,Siliguri,Darjeeling . Details process of theft is enclosed with INSPECTION report.

As theft of Electricity was detected during inspection in our presence and his representative , Inspection team requested to Manoj Agarwal (representative of Amit Goyal) who has been presence of the place of occurrence to become seizure witness. So I seized the above meter in presenting seizure list in presence Sri A. Mahandeo ,D.E. (S & LP) Pranab Sikhder SO (S & LP) ,Sri Sourav Bhattacharya ,Sr. O.E. ,Rajesh Kumar singh ,Sr. T.S.H. Siliguri Town CCC and duly signed by the witnesses and taken into my custody. Copy of seizure list was handed over to the above said accused person.

Thereafter I along with my team left the premises.
