With due respect I, Sri. Sunil Agarwal, Son of Sri. Bijay Agarwal, Residence of Sagar Tea House, Maruti Building, Dr. Kalinath Road, Naya Bazar, Police Station- Siliguri, District- Darjeeling, Pin-734001, West Bengal, would like to draw your kind attention to the following facts:-

- 1. That a) Sri. Rohit Agarwal, Son of Sri. Gopal Agarwal, (mob no-95640 92111)
 - b) Sri. Gopal Agarwal, Son of not known, (mob no-77970 67780)
 - c) Smt. Manju Devi Agarwal, Wife of Sri. Gopal Agarwal
 - d)Smt. Ankita Agarwal, Wife of Sri. Rohit Agarwal (mob-78650 53281) all are presently residing at Shivaji Road, Khalpara, Ward No.8, Siliguri (M.C), District-darjeeling, West Bengal, presently residing at Raj Medico, Opp: -Model Town Apartment, 3rd Floor, Iskon Mandir Road, Siliguri.
- 2. That I, got to know about Rohit Agarwal through one of our common friend namely Sourav Agarwal and he approached me with a business proposal, due to our friendship and trust, I gave him Rs.16,00,000/-(Rupees Sixteen Lac) only for Coal Business purpose with condition that he will share his 50% profit amount in every 10 days in a month.
- 3. That I gave him the total amount in three phases. At first I gave him Rs.6,00,000/-(Rupees Six Lac) only on 16.08.2022 and second amount Rs.6,00,000/-(Rupees Six Lac) only on 08.09.2022 by cash and the rest amount of Rs.4,00,000/-(Rupees Four Lac) only on 17.10.2022 through Bank Transaction.
- 4. That after paying the profit amount for two months i.e for August and September he stopped paying the profit amount for the month of October and when I asked for the money he refuse to pay me back. He did not answer my calls and also did not reply of my messages.

- 5. That whenever I called Rohit Agarwal to meet me and explain me the whole situation that why he did not pay me and answer my calls and messages but he did not pay any heed in my suggestion and totally ignored me.
- 6. That when I went his home for my money his father threaten me that if I continuously want my money back then they will pay me nothing and push me hard, also said that they will kill my 3 years daughter.
- 7. That his wife and mother threat me that they will charge me in false case that I have done misbehave and assault with them and they throw me out from their home.
- 8. That after take all possible step, I have no other way but to reach to the police station for help.

It is therefore my humble request towards you to investigate the matter and take necessary step so that the accused persons get punishment for the ends of justice.
