Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Gauranga Das (present user), (Mob-9749734768) Near babu Bidi Factory, Subhash Pally, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 09.11.2022 at about 01.26 p.m. acting on a source information I, along with 1) Sri Amarasish Mahandeo, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Gauranga Das and inspected service installation, metering installation of Consumer ID 412025906 in the name of Prafulla Das. During inspection it was found that electricity was being used unauthorisedly & illegally by Gauranga Das by reconnecting the disconnected service line of the metering installation that was disconnected previously on 25.02.2022 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Genus Power Infra Ltd, serial no.- G1479950 installed against Con Id. 412025906 seized by preparing a formal seizure list duly signed by representative of Gauranga Das and witnesses. The copy of the seizure list handed over to representative of Gauranga Das and his signature obtained as token of receipt.

As Gauranga Das have committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
