In course of my said: ht mobile van duty at 00.05 hrs on 10.11.2022. I received a secret source information from my source that one Nikunja Roy stored a huge quantity of illegal SPIRIT inside his house at Hatiadanga Near Matangini School in order to its illegal selling for his wrongful gain . I immediately informed O/C Ashighar OP and as per his direction wasting no time I along with my accompanied force left for Hatiadanga Near Matangini School to verify the veracity of information. On reaching at Hatiadanga Near Matangini School area as indicated by my source I held raid at the house of Nikunja Roy at Hatiadar ga Near Matangini School .But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted articles from inside his house. On demand he failed to produce any valid documents for such illegal possession of such articles he gave different statement in different time. During interrogation the above accused person confessed that he along with his nephew namely Jayanta Biswas @ Liton S/O Nipen Biswas of Hatiadanga Near Matangini School PS Bhaktinagar dist. Jalpaiguri and one Shyamal Debuach stored the above Spirit at his house for its illegal selling for their wrongful gain.
