Sub: Prayer for lodging FIR

Respected Sir,

With due respect and humble submission I, SI Shibdhan Karmakar of Pradhanagar P.S beg to state that on 11.11.2022 at 12:30 hrs I arrested one (01) person namely Arpan Sankar (20) S/O Upendra Sankar presently of Bhanunagar, P.S: Bhaktinagar, Dist: Jalpaiguri and permanent address: Prakritigram, P.S: Sadar, Dist: Darjeeling from Salbari Bazar under Pradhanagar P.S. and seized some stolen gold ornaments and cash in c/w Pradhanagar P.S. Case No: 748/22 Dt: 21.09.2022 u/s 380 IPC as stolen recovered properties from his possession. During interrogation he admitted his involvement in this case. At 13:10 hrs I brought him to police station and kept him at P.S. lockup after thorough search and observing all the legal formalities laid by apex court.

On 11.11.2022 at 16:45 hrs the accused Arpan Sankar tried to commit hanging at main P.s lock-up in ventilator bars with the help of torn piece of bed sheet as ligature material. At 16:55 hrs on duty police personnel found him hanging and immediately rescued him by cutting the piece of bed sheet by which he tried to commit suicide.

The accused Arpan Sankar has immediately shifted by me and other available police personnel in police vehicle to the nearest Medica North Bengal Clinic where he got admitted at 17:15 hrs. Now, he is under the treatment in ICU of that nursing home. I immediately requested I/C, Sadar P.S, Darjeeling to inform his family members regarding the aforesaid incident and asked them to come to Siliguri. At 22:50hrs his mother Smt. Sangita Sankar and relatives arrived at Medica North Bengal Clinic and I arranged to meet them with the patient. It has come to know from the mother and other family members that the accused Arpan Sankar was previously admitted at rehabilitation center.


Under the above facts and circumstances I request you to kindly lodge a FIR against the accused Arpan Sankar under proper section of law and arrange for its investigation.
