With due respect and humble submission, in producing herewith one accused namely Shiv Kumar Ray (32) S/O Sri Bhajan Ray of Jagadish Pur, P.O- Bhadiyan P.S-Nanpur, Dist.Sitamari, Bihar under arrest along with following articles under proper seizure ;

- i) 11(Eleven) Plastic bottles of "Millennium XXX Rum " , Blended and bottle by Mount Distilleries Ltd. Mazitar Rangpo, **Sikkim**, each containing 750 Ml, each MRP 185/-
- ii) 12(Twelve) Plastic bottles of "TIGER " XXX RUM , Blended and bottle by Kanchanjunga Distilleries & Liquors ,Manpur, **South Sikkim** , each containing 750 Ml, each MRP 184/-
- iii) 21(Twenty one) Glass bottles of "SIKKIM XXX Prize Rum " , Blended and bottle by Sikkim Distilleries Ltd. Rangpo, **Sikkim**, each containing 375Ml, each MRP 120/-
- iv) One Green Colour Trolley bag ,written as aliva
- v) One white colour Gunny bag ,written as "Jarandeshwar "

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 12.11.22 in course spl mobile van duty at PS area with force CV / 992 Jagadish Biswas ,CV/646 Baban Das ,CV/242 Rakesh Mongar vide PDN PS GDE NO 819 dtd.12.11.22. During Mobile duty at 20.25 hrs , I received an information that the one person suspiciously moving at Siliguri Junction area near Raj Bus Counter under Pradhannagar PS with a trolley band and one gunny bag .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search trolley bag and gunny bag recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he carrying the liquor from Sikkim illegally without obtaining valid document for sell the same in Bihar in high price for his illegal gain . Accordingly, I seized & label the above noted articles in between 21.15 hrs to 21.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Shiv Kumar Ray (32) S/O Sri Bhajan Ray of Jagadish Pur, P.O- Bhadiyan P.S-Nanpur, Dist.Sitamari, Bihar and arrange for its investigation.
