Sub : Prayer for taking legal action.

Respected Sir,

With due respect I, SMT. BHUMIKA BARMAN, W/O - Jitu Barman, resident of Fairanjote, Post. - Ranidanga, P.S. - Bagdogra, Dist. - Darjeeling, beg to inform you that today on 11/11/2022, at about 5.00 pm, my husband Jitu Barman was returning home with his TATA AC four wheeler goods career vehicle and when was coming, near Kawakhari Kaptapuri Basti (near Lohar Bridge) at that time 1. Mantu Barman, S/o - not known, 2. Apon Barman, S/o - Mantu Barman, 3. Swapan Barman, S/o - Mantu Barman, 4. Sushila Barman, W/o - Mantu Barman, all are resident of Kawakhari, Kamtapuri Basti, P.S. - Matigara, Dist. - Darjeeling, all on a sudden all the persons attacked upon my husband with sharp knife, Lathi, Axe etc with a motive to kill my husband and they somehow stop the vehicle of my husband and started to assault my husband and injured the body part of my husband heavily with the sharp knife (Dao, Hasua) and several body parts of my husband are cut with the sharp knife and one hand is almost completely cut by them and my husband is deadely injured with extremely bleeding.

It is pertinent to mention here that after that my husband was taken to NBMC & hospital for his treatment and now he is fighting with his life as several body parts are not functioning.

It is to be noted here that my husband is a driver by profession and today he went to deliver some Furniture from a shop as per order as he use to do regularly and after the delivery of said Furniture, my husband was returning, taking the price of Furniture and rent and at that time all the above named culprits attacks upon my husband and they all mercilessly injured upon my husband with a motive to kill him and after that they also snatch the total collection amount of my husband near about Rs. 50,000/- and after that when the local people gathered and protested about the incident then they all fled away from the place.


It is very unfortunate that all the above named persons are dangerous in nature and they can do everything as they threatened before my husband and they also have threatened that they have High profile Political holdings as such we can do nothing and they also threatened that in future they will ruin our family.

Therefore, I am praying before you to enquire into the matter immediately and take a legal action against all the above named persons and punish them as per law as my husband can get justice.
