1. That I, my wife, my minor son & daughter, my elder brothers along with my mother residing at my aforesaid address, my said mother is an old and senior citizen and due to old age she is suffering from ill health.
2. That I am the small businessman and have Ticket counter, zerox and now started to provided brick to construction area.
3. That today dated: 11-11-2022 in the morning at about 8:30 a.m. 1.Ajay Ghosh, 2.Sunil Kumar Ghosh and 3. Bijay Ghosh all are son of Late Sudhir Kumar Ghosh, resident of Vidysagar Pally, Vidyasagar Road, Near Shitla Mandir, ward No.7 of SMC, Police Station: Siliguri, District: Darjeeling came at my aforesaid residence and without any matter started using slang languages to me and when I heard and asked why you are using wrong word against me then they furious at atrandom pushed me with using fist and blow and after that my wife came and tray to save me from him then they are also tear my wife's saari, using filthy languages and pushed and snatched golden chain from my wife's neck and when my wife and me also loudly called for save me then they said they are Boss of the locality and why without their permission I have started brick sale business If I want to do the said business in the aforesaid locality then any how they will take monthly Gunda Tax Rs.10,000/- (Rupees Ten thousand) neither they will obstruct of my business and they will also said If I disclosed the matter to any Police authority then they will manage the matter because they have political Power and after they will not hesitate to kill us or kidnapped me or my any family member. Now this incident my family member are fear.

So, under the above circumstances I therefore request you kindly enquire the matter and arrest the accused namely **1.Ajay Ghosh, 2.Suil Kumar Ghosh and 3.Bijay Ghosh** and recover my golden chain from their custody and also punished him as per provision of law. For this I shall always obliged you.
