1. I have the honour to submit that on 11/11/2022 at about 2300 hrs, my elder brother Shanto Roy was on guard duty at the gate of Siliguri Foods Pvt Ltd. The vehicle no WB-57B 4873 was being driven in a rash and negligent manner due to which three fingers of the right hand of Shanto Roy got dissected on the spot thereby causing a grievous injury and loss of fingers on the body of the person.
2. Shanto Roy has been evacuated to North Bengal Medical College & Hospital and presently under treatment by the doctors.
3. This is submitted for general diary and fulfilment of legal procedures please so as to compensate the loss of the injured person. Thanking you.
