With due respect, I am producing herewith the arrested accused persons namely (i) Purosutam Dev (21) s/o Kt. Partha Dev of Hakimpara, near T.S Club, Ward No.- 13, PS- Siliguri, Dist.- Darjeeling P/A Dewniya More, Shiv Mandir, PS+PO-Matigara, Dist.- Darjeeling (ii) Soumyojit Tarafdar (23) s/o Lt. Biswajit Tarafdar of Haidarpara, near S.B.I bank, Ward No.- 40, PS-Bhaktinagar, Dist.- Jalpaiguri (iii) Md. Jahid (25) s/o Md. Azizul of Chunavati, Purba Dhantala, PS- NJP, Dist.- Jalpaiguri (iv) Sonu Barman @ Chotu s/o Homeshwar Barman of Jyotirmoy Colony, PS-NJP, Dist - Jalpaiguri and the following articles under seizure :-

1. One Iron made sabol, One Torch Light & One Bhojali from the possession of accused Purosutam Dev (21) s/o Kt. Partha Dev of Hakimpara, near T.S Club, Ward No.- 13, PS- Siliguri, Dist.- Darjeeling P/A Dewniya More, Shiv Mandir, PS+PO-Matigara, Dist.- Darjeeling.
2. One sharp cutting Bhojali and Blunt Iron Rod from the possession of accused Soumyojit Tarafdar (23) s/o Lt. Biswajit Tarafdar of Haidarpara, near S.B.I bank, Ward No.- 40, PS-Bhaktinagar, Dist.- Jalpaiguri.
3. One sharp cutting knife and Screw Driver, one Torch Light and One Iron Rod measuring 45 Inch from the possession of accused Md. Jahid (25) s/o Md. Azizul of Chunavati, Purba Dhantala, PS- NJP, Dist - Jalpaiguri.
4. One iron made Hasua from the possession of accused Sonu Barman @ Chotu s/o Homeshwar Barman of Jyotirmoy Colony, PS-NJP, Dist.- Jalpaiguri.

1. ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 09.11.2022 at 0205 Hrs I received a secret source information that a gang of miscreants come to below Kashmir Colony More, under PS- NJP, Dist - Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Gate Bazar. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 378 dated 09.11.2022. As per kind order and direction of my superior officer myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Kashmir Colony More to work out the information in hand. I also informed the fact to night RT Van officer PSI-Prakash Chandra Sarkar of New Jalpaiguri PS, Siliguri Police Commissionerate and directed him to come to Gate Bazar to accompany with us during Raid. At about 0255 hrs on 09.11.2022 we arrived at Kashmir colony More, under New Jalpaiguri PS. After a few time night RT van officer PSI-Prakash Chandra Sarkar of New Jalpaiguri PS, SPC along with force came to Noukaghat and accompany with us. At about 0335 hrs we found that 10/11 persons assembled in a dark place at below Kasmir Colony More and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 05 (Five) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. On search of the apprehended accused persons I found (i) One sharp cutting Bhojali and Blunt Iron Rod and Small Hammer from the possession of accused One Iron made sabol, One Torch Light & One Bhojali from the possession of accused Purosutam Dev (21) s/o Kt. Partha Dev of Hakimpara, near T.S Club, Ward No.- 13, PS- Siliguri, Dist - Darjeeling P A Dewniya More, Shiv Mandir, PS+PO-Matigara, Dist.- Darjeeling (ii) One sharp cutting Bhojali and Blunt Iron Rod from the possession of accused Soumyojit Tarafdar (23) s/o Lt. Biswajit Tarafdar of Haidarpara, near S.B.I bank, Ward No.- 40, PS-Bhaktinagar, Dist.- Jalpaiguri (iii) One sharp cutting knife and Screw Driver, one Torch Light and One Iron Rod measuring 45 Inch from the possession of accused Md. Jahid (25) s/o Md. Azizul of Chunavati, Purba Dhantala, PS- NJP, Dist.- Jalpaiguri (iv) One iron made Hasua from the possession of accused Sonu Barman @ Chotu s/o Homeshwar Barman of Jyotirmoy Colony, PS-NJP, Dist.- Jalpaiguri
