Sir,  
In producing herewith the two (02) arrested accused persons namely (i) Md. Arif Sk. (29) s/o Bazul Sk of Shershi Nayagram, PO- Shersahi, PS- KaliaChok, Dist.- Maldah (ii) Md. Nasimul Haque (30) s/o Azer Shek of Mazampur, Harachock, PS- Kaliachok, Dist.- Maldah (Not verified) along with the following seized articles under proper seizure list :-

Total 04 numbers of plastic Pouch containing Total 1.003 Kg [One Kilo Gram] Approx of suspect to be Brown Sugar Marked as follows :-

- (i) One packet of Plastic Pouch containing 204 Gram [Two hundred and Four Gram] of suspect to be Brown sugar kept in light Green color Polythene marked as Exhibit-"A".
- (ii) One packet of Plastic Pouch containing 203 Gram [Two hundred and Three Grams] of suspect to be Brown Sugar kept in light Green color Polythene marked as Exhibit-"B".
- (iii) One packet of Plastic Pouch containing 303 Gram [Three hundred and Three Grams] of suspect to be Brown Sugar kept in Pink Color Bag marked as Exhibit-"C".
- (iv) One packet of Pouch Plastic containing 293 Gram [Two hundred and Ninety Three Gram] of suspect to be Brown Sugar kept in Pink Color Bag marked as Exhibit-"D".
- (v) One Light Green Color Polythene.
- (vi) One Pink Color Bag.

NOTE:- Exhibit "A" & Exhibit "B" kept in Light Green Color Polythene seized from the possession of Md. Nasimul Haque (30) s/o Azer Shek of Mazampur, Harachock, PS- Kaliachok, Dist.- Maldah.

I, SI Pradeep Diyali of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted Two (02) arrested accused persons to the effect that today 11.11.2022 at about 1625 hrs I received a specific source input that two persons were standing at Canal Road near Dram Land Restaurant with huge quantity of Brown Sugar for delivering the same to their designed customers. The matter was diarized vide NJP PS PS GDE No. 487 Dt. 11.11.2022 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Sajal Das, VP/08 Laxman Roy, HG/794 Ranjit Roy CV/116 Rohit Kumar Mahato all of NJP PS, Siliguri Police Commissionerate being headed by me left for Canal Road near Dream Land Restaurant by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 488 dated 11.11.2022 and M.C.C. No. 1145/22 dated 11.11.2022. In the mean time I also informed the RT Van Officer SI Prasan Tamang of New Jalpaiguri PS, Siliguri Police Commissionerate, to accompany us. Further I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Canal Road near Dram Land Restaurants to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 1655 hrs we arrived at Canal Road near Dream Land Restaurants and on the way to the spot, I called two independent witnesses namely (i) Sukamalsen Gupta s/o Lt. Subirsen Gupta of Shaktigarh Road No.- 03, PS- NJP, Dist.- Jalpaiguri (ii) Saumiya Bikash Ghosh @ Babai s/o Lt. Jyoti Prakash Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that two persons carrying Polythene and Bag in their hand were standing in front Sujoy Store, near Dream Land Restaurant, Canal Road under PS- NJP, Dist.- Jalpaiguri which was matched with our information. Accordingly, we intercepted the two persons who disclosed their identity as noted above.
