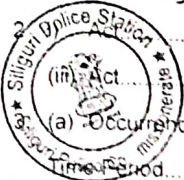

Mantu Das, became the legal heir of said vested land, but my elder brother in law namely Sharat Chandra Das S/o Lt. Mantu Das also died, but the said alleged person namely Smt. Lalita Das (My elder sister in law) W/o Not known, ~~Person~~ and my elder-brother-in-law Raju Das S/o Lt. Sarat Chandra, both as permanent resident of Near Gaushtala, Vasant Kunj, Delhi, ~~came~~ have come at Siliguri and trying to evict me from said 1/2 Katha land at Ganga Nagar.

On dt. 9.11.22 at about 12:00 pm. In the afternoon I entered into my said husband's plot, dtf Ganga Nagar. (Near Shani Mandir) since from the said alleged persons are picketing me and threatened me for these consequences, if I will not leave said plot.

So, there is possibility of commission of breach of peace & tranquility from their side. So, please take necessary action against said alleged persons.
