II] One (01) bottle of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) randomly taken from "Exhibit- A" for examination and marked as "Exhibit A-1". III] One multi colour hand bag styled as 'MARATHA' containing 08 (eight) bottles of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) having Batch No. DVNLC224, which was - seized from exclusive and conscious possession of above noted Bikrant Roy and marked as "Exhibit- B". IV] One (01) bottle of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) randomly taken from "Exhibit- B" for examination and marked as "Exhibit B-1".

Sir,

In producing herewith two (02) arrested accused persons namely 1] Dipesh Gowala(21) S/O Unil Gowala, and 2] Bikrant Roy (25) S/O Rishi Roy both of Jhanju Para, Fata Pukur PS. Rajganj, Dist. Jalpaiguri along with the following articles under proper seizure as per seizure list;

I] One multi colour hand bag styled as 'Hello Kitty' containing 08 (eight) bottles of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) having Batch No. DVNLC224, which was - seized from exclusive and conscious possession of above noted Dipesh Gowala and marked as "Exhibit- A".

II] One (01) bottle of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) randomly taken from "Exhibit- A" for examination and marked as "Exhibit A-1".

III] One multi colour hand bag styled as 'MARATHA' containing 08 (eight) bottles of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) having Batch No. DVNLC224, which was - seized from exclusive and conscious possession of above noted Bikrant Roy and marked as "Exhibit- B".

IV] One (01) bottle of "P - KUFF" Cough Syrup ('Codeine Phosphate' based drugs, each bottle containing 100 ml) randomly taken from "Exhibit- B" for examination and marked as "Exhibit B-1".

I, SI Sumit Rawat (32), S/O- Puran Rawat of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused persons namely Dipesh Gowala and Bikrant Roy to the effect that on 13.11.2022 at about 07:05 hrs I received a specific source input that two persons possessing huge quantity of 'Codeine Phosphate' based drugs to sell the same to his designed customers at Jalpaimore area under Siliguri PS. The matter was diarized in Siliguri PS GDE No. 692, Dt. 13.11.2022 and subsequently, I informed the matter to the Inspector - In-Charge, Siliguri Police Station in written and being directed, myself along with ASI Siben Sarkar, ASI Subir Sen, ASI Debasish Das, CV 622 Rama Nath Barman and CV 283 Prasanjit Dey all of Siliguri PS, SPC along with investigation kit left for Jalpaimore area under Siliguri PS by Govt. vehicle to verify the veracity of the information. This refers to Siliguri PS GDE No. 693, Dt. 13.11.2022 and M.C.C No- 1796/2022 Date- 13.11.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Jalpaimore area under Siliguri PS I contacted two persons namely 1] Bhola Routh (34), S/O- Lt. Suresh Routh of Jalpaimore, Natunpara, Near School Ground, W/No - 5, PS. Siliguri, Dist. Darjeeling, Ph. No - 8617453608 and (2) Amit Biswas(31), S/O- Shibu Biswas of RBS Club, New Milanpally, W/No - 25, PS. Siliguri, Dist. Darjeeling, Ph. No - 7074058046 and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which, they agreed. Thereafter, we along with above noted independent witnesses arrived at Jalpaimore, under PS- Siliguri at 07.35 hrs and subsequently, being pointed by my source, detained 02 (two) persons who were standing at Jalpaimore, Near Kali Mandir and were carrying hand bag under their exclusive and conscious possession. Thereafter, we disclosed our identity and the information in hand stated them that they as well as the bags under their possession will be searched for the purpose. And, I also gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to Shri Sudip Chakrabrotty, I/C Siliguri PS regarding the interception of the accused persons suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Jalpaimore, Near Kali Mandir, under Siliguri PS to remain present and to supervise the search and seizure.

Accordingly at 08.05 hrs Shri Sudip Chakrabrotty, I/C Siliguri PS, arrived at the spot at Jalpaimore, Near Kali Mandir, under Siliguri PS and in presence of two independent witnesses I searched the detained persons namely Dipesh Gowala and Bikrant Roy following all formalities, keeping their decency and recovered the above noted articles of the accused persons namely Dipesh Gowala and Bikrant Roy .

It has been found from the bag under the possession of the above noted accused person namely Dipesh Gowala containing 08 (eight) bottles of "P - KUFF" Cough Syrup (Codeine Phosphate' based drugs, each bottle containing 100 ml) containing 08 X 100 ml = 800 ml i.e., equivalent to 800 gram.

And It has been found from the bag under the possession of the accused person namely Bikrant Roy containing 08 (eight) bottles of "P - KUFF" Cough Syrup (Codeine Phosphate' based drugs, each bottle containing 100 ml) containing 08 X 100 ml = 800 ml i.e., equivalent to 800 gram.

Further, on demand in presence of Shri Sudip Chakrabroty I/C Siliguri PS /SPC the detained persons namely Dipesh Gowala and Bikrant Roy failed to produce any valid documents/papers or explanation for possessing of such huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 08 (eight) bottles [containing 800 ml i.e., equivalent to 800 gram] of "P - KUFF" 'Codeine Phosphate' based Cough Syrup [including 1 (one) bottle of "P - KUFF" 'Codeine Phosphate' based Cough Syrup (containing 100 ml) which was taken randomly from the mother packet for examination] from the exclusive and conscious possession of above noted accused person namely Dipesh Gowala and 08 (eight) bottles [containing 800 ml i.e., equivalent to 800 gram] of "P - KUFF" 'Codeine Phosphate' based Cough Syrup [including 1 (one) bottle of "P - KUFF" 'Codeine Phosphate' based Cough Syrup (containing 100 ml) which was taken randomly from the mother packet for examination] from the exclusive and conscious possession of above noted accused person namely Bikrant Roy at the spot at Jalpaimore, Near Kali Mandir under Siliguri PS, Dist- Darjeeling under proper seizure list in presence of independent witnesses and Shri Sudip Chakrabroty I/C Siliguri PS /SPC obtaining their signature and being acknowledged by the accused persons namely Dipesh Gowala and Bikrant Roy.

Subsequently, I labelled and sealed the seized articles in presence of Shri Sudip Chakrabroty I/C Siliguri PS /SPC and independent witnesses and the accused persons namely Dipesh Gowala and Bikrant Roy. The whole process of seizure was made in between 08.15 hrs to 08.50 hrs.

Being further interrogated, the apprehend persons namely Dipesh Gowala and Bikrant Roy admitted in presence of Shri Sudip Chakrabroty I/C Siliguri PS /SPC and independent witnesses that they have procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for their wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Dipesh Gowala and Bikrant Roy are involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Dipesh Gowala and Bikrant Roy after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.




