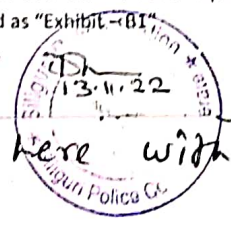

Sir,

In producing herewith one (01) arrested accused person namely (i) Chandan Rajbhar (35yrs) S/o- Sital Rajbhar of Falimari, PO- Akharhat, PS- Kotwali, Dist- Coochbehar (not verified) along with the following articles under seizure as per seizure list:

- i) One Blue and Red colour big handbag containing 11.100 Kg of "Ganja" wrapped with Brown colour cello-tape and marked as 'Exhibit-A',
- ii) 25 grams of ganja extracted from exhibit 'A' for chemical examination and marked as 'Exhibit A-1'
- iii) One Marron and Red colour big handbag containing 12.500 Kg of "Ganja" wrapped with Brown colour cello-tape and marked as 'Exhibit-B',
- iv) 25 grams of ganja extracted from exhibit 'B' for examination and marked as 'Exhibit B-1'
- v) One Deep Blue Colour keypad mobile phone styled as "SAMSUNG DUOS" with SIM Card.

I, SI Kankan Paul (50yrs) S/o- Lt. Harendranath Paul of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted person to the effect that on 13/11/2022 at about 14:15 hrs I received a specific source input that one person was standing at airview more under PS Siliguri with huge quantity of Ganja for delivering the same to his designed customers. The matter was diarized in Siliguri PS GDE No. 728 Dt- 13.11.2022 and also informing the matter to the Inspector-In- Charge, Siliguri Police Station in written and being directed, I along with SI Basudeb Guha, SI Sumit Rawat, ASI Siben Sarkar all belongs to Siliguri Police Station left for Airview more under PS- Siliguri by Govt. vehicle to verify the veracity of the information vide Siliguri PS M.C C. NO 1805 Dt. 13/11/2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from Police Station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

On way to Airview more, I contacted two persons namely (i) Prakash Kr Sha (32yrs) S/o- Lt. Adalat Sha of Hill Cart Road, Mahananda Para, W/no- 06, PS- Siliguri, Dist- Darjeeling, (ii) Rana Dutta (33yrs) S/o- Rantu Dutta of Jhankar more, PS- Siliguri, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached at By Airview More, at 14:45 hrs and subsequently being pointed and shown by my reliable source apprehended above noted person.

Thereafter, we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he have illegally possessed ganja in his possession for selling the same to his designed customers as per requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, he did not search the police party.

Accordingly, I informed the matter to I/C Siliguri PS and as per his kind order, I informed to Sri Asish P Subba, Assistant Commissioner of Police, Traffic (West) , Siliguri Police Commissionerate acting as Special Executive Magistrate, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Ganja and requested him to come at Airview more to remain present and to supervise the search and seizure. At 15:40 hrs Sri Asish P Subba, Assistant Commissioner of Police, Siliguri Police Commissionerate arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses search has been conducted of the detained person following all formalities keeping his decency and recovered the above noted articles from the conscious possession of accused Chandan Rajbhar. On demand, in presence of Sri Asish P Subba, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC the detained person namely Chandan Rajbhar failed to produce any valid document in support of possessing of the Ganja.

Thereafter, I weighted the recovered bags and packets with the weighing instrument which stand total of 23.6 (twenty three Kg and six hundred grams) Kg in two packets [1] (11 Kg 100 grams) and [2] (12 Kg 500 grams) and also extracted 25 grams ganja from each packets for chemical examination. Then, I seized the above noted articles at the spot under proper seizure list and also labeled and sealed the articles in presence of Sri Asish P Subba, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC and independent witnesses and also obtained signature of the above noted witnesses and the Special Executive Magistrate, SPC and put my signature too and also acknowledged by the accused person. The whole process of seizure was made in between 15.45 hrs to 16.25 hrs.

Being further asked the apprehend persons namely Chandan Rajbhar admitted in presence of Sri Asish P Subba, Assistant Commissioner of Police, Siliguri Police Commissionerate and other witnesses that he have procured the ganja clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he have been dealing in such business of procuring and selling of ganja illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Chandan Rajbhar is involved in procuring and selling of Ganja illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Chandan Rajbhar after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.


