Respected Sir,

With due honour I Md Arif Hasan, Son of Amir Hasan, residence of Purbo Dhontola, S.S Tipi Binnaguri, Fulbari II, P.O. Satellite Township, P.S. New Jalpaiguri, Pin. 734015 in the State of West Bengal is lodging this complaint to the effect that I am the employee of Jalpaiguri Fruit Center (Popularly known as JFC) as senior salesman and I have been working under this private company for 8 months. Under this job it is part of my duty to deliver the bunch of banana (in caret) to the respective sellers and collect payment from sellers in the market. Following my dairy working routing I met with Mr. Dinesh (M/b-77185-92790) who is the one of the customer of our company's product and also a seller of fruits at Checkpost bazar having his own shop. As he is one of the regular customer of our company's product, I used to deliver the bunch of banana (in caret) to him for months regularly and in pursuing of that a sum of Rs. 31,840 (Thirty one thousand eight hundred forty rupees) has become due before him till date. On today (dt. 14-11-2022) morning, when I visited to his shop after pursuing his demand of banana, he made a rude behaviour to me and seized my two caret (bunch of banana) with him without giving any single penny of amount value of Rs. 900 (Nine Hundred Rupees only). Meanwhile when I asked my payment of 2 Caret (bunch of banana) and his due as mentioned above, he beat me wildly along with his associates and snatched my phone and destroyed it voluntarily. I tried to my level best to be calm but still he threaded me to kill my life as if I asked my remaining amount before him next time.

Till today I have not received my justified payment from him as mention. This the a clear breach of words and I feel betrayed and cheated as they are refusing to pay which is their utmost duty even they are neglecting and dishonestly using my property to his own purpose.

That in fact he has kept me in dark from the very inception and has been implying delaying tactics under the guise of legal complications with a view to grab our hard invested money. The intention of the said was dishonest and fraudulent at the time of making the promise and he has deliberately and intentionally misappropriated the investment of mine for his own gain.
