

action on behalf of the applicant.

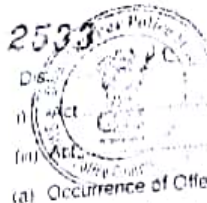
