Dear Sir,

With due respect I the undersigned would like to inform you that, last night at about 9.30 P.M. I was standing in front of my house situated at Niranjn Nagar, Vivekananda Sarani, Ward No. 36 of S.M.C., P.O Ghogomali, P.S Bhaktinagar, Dist. Jalpaiguri and at the relevant time Two persons namely **Jay Mali** and another person name not known, and said Jay Mali was driving his motor Bike (**WB-64-W-9327**) very carelessly and very fast. When I said him to drive carefully he started filthy language and said that it's my Bike I brought this Bike my own money and I will drive in my way. When I told him do not speak filthy language then he started threatening me and said to me if he have/had not listen me then what I will do, then he get out of his bike and come close to me and pushed me in my chest. Then I told him don't do this, in the mean time the another boy call Jay Mali's brothers namely **Hriday Mali** and **Iswar Mali** over telephone, and they come within 5 minutes and hit me without knowing any matter. They have/had thrown me into the ground and started hit me, they have/had kicked me punching on my face, chest, and one of them suddenly snatch my golden chain from my neck. In the mean time one of them hit me a big Stone on my head and my head is bursting immediately. Thereafter when I saw my head and my face fully covered by my blood I started shouted loudly then my family member and my friend come there and rescue me from them and broyght me to the Siliguri District Hospital and I have/had treated there. Due to such my injury the doctor bandages my head.

I would like to request you to investigate the matter and take necessary action on them for the ends of justice.
