Sir,

I, Prashanta Kumar Mahato, Assistant Engineer and Station Manager, Milanpally CCC do hereby lodge complaint against Mr. Biki Balmiki, Tikiapara Ambedkar Colony, PS-Siliguri, Dist.-Darjeeling, at about 14/11/2022 hours in pursuance of a secret information. I along with Mr. A. Mahandeo, DE(Electrical), Darjeeling Regional & Mr. Pranab Sikder, S.O., Darjeeling Region along with on duty mobile van personnel inspected the under construction house after issuing notice and detected one service cable was connected from LT network like as regular line but he is not a consumer of WBSEDCL. On further checking, it was also found that Mr. Biki Balmiki was consuming electrical energy for DOMESTIC purpose as mentioned in the inspection report by direct hooking from LT network by using 15 metre service cable.

As they have committed offence as punishable u/s 135(1)(a) of Electricity Act. Hence, I seized PVC cable (approx 15 metre) after preparing the seizure list duly signed by all. An inspection report was also prepared and necessary copies were served to the representative of Mr. Biki Balmiki

The physical load was found 116 W and period of offence is last one year.

Therefore, you are requested to register a case u/s 135(1)(a) of Electricity Act against Mr. Biki Routh and arrange for its investigation
