Respected Sir,

I, the undersigned, would like to inform you that, my younger brother namely Sudipta Saha, resident of Green Avenue, East Vivekanandapally, Ward no. 38, Dist - Jalpaiguri.Siliguri-734006, who is the Owner of a shop room under the name and style M/S. 'Tandoori Chai', situated at Nivedita road, Pradhannagar, dist. Darjeeling and he doing his business there with full of good reputation and well behaved since long.

I would like to further inform you that yesterday i.e. on 14-11-22, at about 10.30 p.m when my said younger brother doing his business, some local goons namely - Chandan Prasad s/o-Madan Prasad ,Rajesh Soni, Rocky Upadhay, Amit Prasad S/o-Madan Prasad all are resident of Gurung busty came to the said shop room and started to abusing filthy languages and suddenly they started to demanding an amount of a sum of Rs. 1 lakh and for their illegal demand my younger brother protested them. It is further mentioned here that the above mentioned miscreants have also threatened my younger brother earlier for this amount.

I would like to further inform you that the above mentioned goons were came at late night when my younger brother started to closing his shop room, firstly they have abusing filthy languages thereafter demanding money and when he refused to pay them thier illegal amount, they have started to mercilessly beaten my younger brother with fist and blows and they have also shown my brother a gun and by using the said gun's butt one of them hit on my brother's forehead and for that he sustained grivious injury, they all have using iron punch, belt and other alements and they have repeatedly shouting taht today they will kill my younger brother why he refused to py their illegal demand. And when local persons accumulated their, said persons fled away by using a threat that if he want to business there he has to pay the gunda tax to them otherwise they will did same and no body can restrain them.

I would like to further inform you that, thereafter one of the staff of my younger brother along with local persons brought by him to the siliguri hospital for his treatment and after hearing the said news i rushed to the hospital but it was more scaring that the said goons are also reached to the hospital and again they beaten my brother with an intention to kill himself but due to some perosns who were stand in the hospital, they haven't succeeded in their illegal mission.

I would like to that, my younger brother sustained grievous injury on his head, nurse and different parts of body and now he's admitted to the Siliguri Hospital with very serious condition under the threat of life and death.

it is pertinent to mention here that there is several cases are pending against the above named accused persons as they are known as local Gunda and political sound.

Under the above circumstances, I would like to request you to investigate the matter and do needful according to the law as the accused persons may punished for their illegal act and activities.
