Sub: First Information Report

Respected Sir,

I the undersigned would like to inform you the following facts as FOLLOWS:

That I am the absolute owner of ALL THAT piece and parcel of land, admeasuring 0.66 Acres, appertaining to L.R. Plot no. 166, 165, 168 and 169 recorded in L.R. Khatian No. 906 of Mouza- Bairatishal, J.L. No. 70, Touji No. 8, P.S. Matigara, Dist- Darjeeling and since then we have been holding, enjoying and possessing the land.

After purchasing the said land somewhere in the year 2016, one Biren Singh and others tried to encroach the suit schedule land from my peaceful possession and therefore I have already filed a Civil Suit being **Title Suit No. 254 of 2016** before the Ld. Court Civil Judge Junior Division at Siliguri against the defendants i.e. Sri Biren Singh and others which is still pending disposal. The Ld. Court was also pleased to pass an interim order that the defendants are hereby restrained from disturbing the peaceful possession of the plaintiff upon the suit schedule land.

However, all of a sudden to our utter shock, recently I got an information from some locals people that wife of Late Biren Singh namely, Smt. Ukila Singh along with some of their associates, who have no right, title and interest over the above schedule land all on a sudden intruded upon my land and started uprooting and clearing out the weeds present in my land. Later, in the last week I was informed by some locals that Smt. Ukila Singh along with some of their associates had bought few mansions into our land and had constructed cemented boundaries around my land and as soon as I got the information my caretaker and few others rushed into the spot and tried to
