
I, ASI Khagen Barman of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Kishan Majhi (36) S/O Lt. Budhan Majhi of Bhujipani PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Fourteen (14) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
2. Ten (10) Ltrs Local made ID Liquor locally called as "Cholai" which kept in two Plastic Jar, each 5 Ltrs, Marked as Exhibit -B in which 01 Ltr taken as sample in a Plastic bottle for examination exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that today on 17.11.22 at 19-25 hrs received secrete source of information that one person was selling Id Liquor illegally from his house situated at Bhujipani, Bagdogra to its customers without any valid license. Accordingly I share the information to duty officer of Bagdogra PS which diarised vide Bagdogra PS GDE No. 759 dt. 17.11.22 and also share to O.C. Bagdogra PS and as per his instruction myself along with, C/1008 Kanak Roy, CV- 386 Kishor Hawlder CV- 389 Janak Singh, VP-01 Ansalam Kujur left for Bhujipani, Bagdogra to verify the veracity of information vide Bagdogra PS GDE No. 760 dt. 17.11.22. On arrival at the spot at 20-05 hrs it was found that one person mentioned above was selling liquor illegally from his house at Bhujipani, Bagdogra to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses namely (1) Dinesh Ghosh (38) s/o Lt. Jitendra Nath Ghosh and (2) Subhash Barman (35) s/o Suren Barman both of Gossainpur Natunpara PS Bagdogra Dist. Darjeeling I recovered Fourteen (14) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml and Ten (10) Ltrs Local made ID Liquor locally called as "Cholai" which kept in two Plastic Jar, each 5 Ltrs from his house at Bhujipani, Bagdogra from the possession of the apprehended person and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 20-25 hrs and 21-05 hrs (seizure Total approx 18.4 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Kishan Majhi (36) S/O Lt. Budhan Majhi of Bhujipani PS Bagdogra Dist. Darjeeling and arrange for its investigation.
