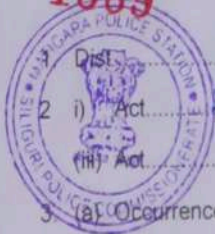

Respected Sir,

I, Pragyant Thapa, grandson of Shri. Prem Kumar Thapa (Rana), aged 36 years, resident of 115, MCW Centre (Bich Gaon), P.O Ghoom, P.S. & Dist. Darjeeling, Pincode-734102, would like to state you that grandfather and my paternal uncle have 16 decimal land situated within Mouza- Baramohan Singh, J.L. No.71, recorded in Khatian No. 934 and 704/1 in part of Plot No. 1188, Pargana -Patharghata, Police Station- Matigara, Dist. Darjeeling. In the year of 2013, Shri. Jay Kishor Shaw Son of Harinath Shaw resident of 1/3, Hartaki Bagan Lane, Dr.Dhiren Sen Sarani, P.O Beadon Street, P.S. Maniktala, Dist. Kolkata-700006, the proprietor of J.K. Construction, who was running and doing business of construction work made contact with me and informed me about his construction firm and also told me about a construction plan for our landed property.

Thereafter my grandson and paternal uncle entered into an agreement for development/construction work upon the said land with Shri. Jay Kishor Shaw. Thereafter the said Sri Jay Kishor Shaw started construction work but after completion of some work he started to delay the construction work and, in the meantime, He also sold the project to third parties for his illegal gain without information and consent from us. Consequently my grandfather filed a suit for declaration and injunction against the said Shri Jay Kishor Shaw before the Ld.Civil Judge Junior Division at Siliguri and same is still pending for adjudication.

On the dated 10th/January/2022 Jay Kishor Shaw illegally rented the ground floor property to the gas dealer for storing the cylinder. This is a residential area, hence the residents caused uproar. After that, the local police took the necessary action. Due to this reason and to save our reputation we locked the entire vacant flats.

After this incident there was no communication between us.

Suddenly on dated 15th/November/2022 at early morning the said Shri. Jay Kishor Shaw illegally entered into the said property breaking the lock. He also threatened us that he will capture the property by any means and if any objection was raised then he will not hesitate to kill me. My grandfather is 85 years old and paternal uncle stay outside India.

So, I request you to look into the matter and take necessary action against the said Sri Jay Kishor Shaw.
