Respected Sir,

I, Subrata Kar, son of Late Satyabrata Kar, residing at Hakimpara, P.S. Siliguri, District Darjeeling is presently employed with Mr. Radheyshyam Agarwal, son of Late Ishwar Chand Agarwal. It is to state that Mr. Radheyshyam Agarwal is the owner in possession of a land measuring 2.96 acres situated at Khaprail Road, Mouza Panchkulguri, P.S. Matigara, Vill Panchkulguri, Dist Darjeeling which is bounded on all four sides by a boundary wall with security guards to look after the land. The said land is recorded in the name of Mr. Radheyshyam Agarwal in LR Khatian no. 195 by paying Khajana/land revenue. I am the caretaker of the said land as Mr. Radheyshyam Agarwal is the resident of Kolkata, West Bengal.

Sir, yesterday (16.11.2022) at around 11:30 a.m. one Khemlal Saiboo, son of unknown, along with Nerey Oraon @ Lalchi Oraon son of Late Langra Oroan, Rakesh Saibo son of Khemlal Saiboo, along with 2 other persons entered the said land armed with iron rods and broke open the front gate. Khemlal Saibo threatened our security guard and directed him to leave the land. When the security guard objected, Khemlal Saiboo caught the security guard by the hair and both Khemlal Saiboo and Rakesh Saiboo started hitting him with blows. Thereafter Khemlal Saiboo, Nerey Oraon and Rakesh Saiboo left the land and directed that security guard to leave the land by evening.

Sir I say that Khemlal Saiboo, Nerey Oraon and Rakesh Saiboo have been trying to trespass into the land and disposes Mr. Radheyshyam Agarwal for the last 5 years or so. Nerey Oraon has also filed a suit in the Siliguri Court wherein the Court after hearing our side had refused to grant any relief to Nerey Oraon. Failing to get any

favourable order from the Court, Khemlal Saiboo, Nerey Oraon and Rakesh Saiboo have become very desperate and dangerous. In order to stake false claim to the land Khemlal Saiboo in collusion with Nerey Oraon and Rakesh Saiboo have prepared forged and fabricated documents.

Sir, I would kindly request you to look into the matter and investigate the fraud and forgery committed by Khemlal Saiboo and initiate appropriate proceedings for the destruction of the property against Khemlal Saiboo and his associates to ensure the safety and security of the land.
