Respected Madam,

I Subra Yasmin, w/o-MD. Ziaul Hoque (SI of Police under Siliguri Police Commissionerate) w/o- MD. Sarajul Islam, presently residing at Matigara, Govt. Colony, P.S. - Matigara, Darjeeling wants to declare some facts that,

- 1) I got married to MD. Ziaul Hoque socially on 18/06/2006 and our marriage was registered on 08/07/2007 under sec. 11 of ACT XLIII of 1954. I have given birth a male child namely MD. Zicamsh Hoque at Neotia, Siliguri on 23/01/2018.
- 2) I got a government job at Health Department on 13/09/2013.
- 3) My husband forcefully takes all my salary since my first salary credits to my bank account and always puts conditions on me i.e., to take transfer of my job to Malda, and transfer the my residential House to his name (he wants ownership of my residential House).
- 4) As I am not ready to fulfill his any conditions. He always tortured me physically and mentally in front of my minor son.
- 5) On 16-11-2021, I was again beaten physically by my husband in front of my minor son as I only wanted to use my salary on my own. For this I have lodged an FIR at Matigara PS vide FIR No. 1305/21. After my FIR my

husband gets more violent against me and my son too and leaves our house at 29/11/2021 with all his essential things along with my original property deeds, original IC deeds and all also my and my sons rations card, my Pan card etc.

6. After some days I got to know that my husband got married with another woman without my consent or willingness, namely Sayeba khatun, age about 27 years, Sol-Salik Sakh of Mirchak, Malda. He started to live with this lady after leaving my house on 29/11/2021 - He leaves me & my minor son alone and also not giving us any financial assistance.

7. Since I got my job my salary was totally used by my husband either by taking loans or by holding my ATM with himself. He never allows me to use my salary on my own. Again he forces me to take loans from my salary account on March 2021, for this I am still paying off all the EMIs i.e. Rs. 13068 + 13034 = 26102/- He always forcefully takes my signature on blank pages and blank checkbooks and use them according to his motives which I even don't know where my signatures are being used.

8) On Dec. 2021, he illegally get my call details by using his police powers through his department and started to harm my character and hamper my reputation in front of my office colleagues, my friends, relatives and to the people of society where I live. He use social media i.e. whatsapp & face book platforms to ruin my ~~character~~ character and reputation. Till now he threats me by his associates.

9) My husband illegally detains a boy namely Bijoyjyoti Dey at Bhaktinagar P.S when he was

Posted there and brutally beaten him to confess the words which my husband want. He uses that boy to prove any illegal ~~scandal~~ ~~scandal~~ relation with me. My husband threatens that boy to involve him in false cases or to harm his job and takes his advantage ~~is~~ by mis-using his police powers. He makes videos of all this and circulates it through social media to my relatives and friends.

10) My husband by using his police powers illegally gained so many properties in his name at Siliguri and Malda also. The total estimate of property in his name nearly or approximately costs about 2 to 3 crores.

11) As I am not ready to accept his conditions he still trying to force me <sup>either</sup> to live with him along with his second wife or forces ~~to~~ me to file divorce.

12) He also started to harm my parents reputation in front of society through social media. He also harm my brother's reputation through social media and also lodged false cases against my father, Mother & brother.

Therefore, I request you to kindly take necessary legal actions against my husband and provide proper justice to me & my minor son.
