Sir,

In producing herewith one accused person named Pramod Roy (45), S/O- Govinda Roy of Natun Bazar, Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

1. 12 (twelve) plastic bottles of Himalayan Gold 60 up country spirit (each bottle containing 600 ml, each MRP 120/) bottled by Himalayan Endeavour Pvt. Ltd., Siliguri, West Bengal (total 7.20 litres) marked as exhibit 'A', out of which 01 (one) bottle is taken as exhibit A-1.

I, PSI Bijay sarkar of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Pramod Roy (45), S/O- Govinda Roy of Natun Bazar, Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling to the effect that today on 17.11.2022 at 20.15 hrs received a source information that one person is selling liquor in a shop situated at Natun Bazar, Dakshin Palash area under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction vide Pradhan Nagar P.S. GDE No.1130/22 dt. 17/11/22 I along with C/1415 Chandan Basak and C/473 Amrita Sarkar, had been to Natun Bazar, Dakshin Palash area under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Pramod Roy (45), S/O- Govinda Roy of Natun Bazar, Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20.55 hrs to 21.25 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Pramod Roy (45), S/O- Govinda Roy of Natun Bazar, Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
