Date of occurrence: - Since the month of January, 2019, on 06/03/2019, 15/03/2019.





The complainant above named begs to state as follows:-

- That the father of the complainant Keshar Lama(since deceased) was absolute owner of the land measuring about 1 Katha 31.75 sq.ft., appertaining to Plot No. 401, Khatian No. 414, J.L. No. 110(88), under Mouza Siliguri, P.S. Siliguri now Pradhannagar, Dist. Darjeeling.
- 2. That said Keshar Lama had purchased the said landed property in the year of 1988 from the recorded owner namely Amir Lama, S/o. Late Santabir Lama by virtue of a registered deed of sale being no. 363 for the year of 1988. The father of the complainant Keshar Lama had very good relation with said Amir Lama and both were belong to the same religion and due to such good relation, when the land was transferred by Amir Lama to and in favour of the father of the complainant, said Amir Lama had also transferred the possession of his adjacent land measuring about 3(three) Kathas to and in favour of him and since then, the father of the complainant had been occupying and possessing the said 4(four) Kathas land freely, openly and without any objection and interruption whatsoever. During the lifetime of Keshar Lama, he had also constructed a residential house in and over his 1 Katha land and the complainant along with her parents had/have been using the said adjacent 3(three) Kathas land of Amir Lama as courtyard.
- That on 07/01/2018, said Keshar Lama died leaving behind the complainant and his wife Nima Bhuti Sherpa as his only legal heirs and successors. Subsequently, the mother of the complainant has transferred her share to the complainant by executing a registered deed of gift.



That since the month of January 2019, some members of Siliguri Lions Service Foundation including the President of said foundation namely Sri. Manish Jajodia have been trying to encroach the aforesaid landed property belongs to the complainant and when the complainant has raised protest, said President and the other members of Foundation have threatened the complainant and her mother with dire consequences and abused them, finding no other alternative, the complainant has lodged a written complaint to the Commissioner of Police on 14/01/2019.

Solemning on Januarian Services on January (Govi. Or Inoia)

That at present the complainant is working in a showroom namely Ritukumar Store, Vega Circle Mall, Siliguri and she is residing in the aforesaid house lonely. The complainant use to come home at around 9:30 to 10:00 P.M. after doing her aforesaid job, but on several occasions including on 06/03/2019, when the complainant was entering into her house, the Security Guard of Siliguri Lions Service Foundation abused her in filthy languages while he was in drunken condition, thereafter, the complainant has informed the matter to the president of said foundation but they did not pay any heed to that.







6. That for the purpose to safety and security, the complainant has decided to cover her house and courtyard by constructing boundary walls and on 15/03/2019, the complainant has started to construct boundary walls, but at about 8:30 P.M., one Manish Jajodia, Dilip Agarwal and the Chairman of Siliguri Lions Service Foundation came to the house of the complainant and started to abuse the complainant in filthy language and asked her to stop the construction of boundary walls otherwise, the life of the complainant will be endanger. When the complainant has tried to convince them that she has every right to construct boundary walls for the purpose to cover her house and courtyard, they became furious and have humiliated and insulted the complainant in presence of so many people by saying that the complainant is not a person of good character, and being a Buddhist and tribal, she does not have any right to reside in such respected area. Subsequently, one Police Officer of Pradhannagar PS namely Mr. Bhutia came to the spot and asked the complainant to stop such construction of boundary walls and threatened the complainant that if she will not settle the matter with the Siliguri Lions Service Foundation, he will arrest the complainant and will not allow her to reside in her house, said police officer has also adviced the complainant to meet with the I.C. of Pradhannagar PS. As too many times were elapsed, the complainant had decided to meet with the I.C. on the next day. But after some times, at about 9:30 P.M., Manish Jajodia, Dilip Agarwal and the Chairman of Siliguri Lions Service Foundation and their men and persons forcibly entered into the house of the complainant and demolished the boundary walls of the complainant illegally.

That finding no other alternative, the complainant went to the Pradhannagar PS for lodging complaint against the accused persons but the O.C. of Pradhannagar PS did not receive any complaint from the complainant and thereafter, the complainant has lodged a complaint to the Commissioner of Police, SMP, to the A.C.P.(west) on 16/03/2019 and also to the S.D.O. Siliguri on 20/03/2019 but till this day, police has not taken any action against the accused persons.

Under the above circumstances, it is prayed that your honour would be graciously pleased to pass necessary order and to send this complaint U/Sec. 156(3) of Cr.P.C. to the I.C., Pradhannagar Police Station with a direction to investigate the matter after treating this complaint as F.I.R. for the ends of justice.

And for this act of kindness your petitioner as in duty bound shall ever pray.
