I, Sri Roshan Kumar Agarwal, S/o. Shri Shyam Lal Agarwal, Presently residing
at Mahalaxmi Garden, Joyshree Villa Apartment, Siliguri, P.S. - Bhakti Nagar,
Dist. Darjeeling. I would like to inform you that date 17/11/2022 Night a
theft has been carried out at my godown premises at East Chayam Paza, Siliguri.

Date of 17/11/2022 Night after I closed my godown and went home, a
theft had occurred at my godown premises. In the morning when we opened
the main gate of our godown premises, which was intact as usual, we found
out that the lock of the wooden gate of one of my rooms at my godown
premises was broken. After entering the room, we found that the iron
almirah in our room was displaced from its original position and the
lock of it was broken into. The CCTV cameras along with the TV
monitor at my godown premises was also removed and stolen after
dismantling all my security facilities and infrastructure.

The total Property that was theft are as follows:-

- a) Cash currency amounting to Rs. 55,000/- (Rupees Fifty Five thousand)
- b) 32" Samsung Led TV = 01 Nos.
- c) Boat Head phone = 50 Nos.
- d) CCTV camera = 01 Nos.
- e) CCTV Setup DBR Box = 01 Nos.
- f) Vimal Pan Masala = 230 Pkts. (approx)
- g) Cigarette = 15 bundle (approx) - Navy cut & classic
- h) Blanket = 12 Nos. (approx)
