Sub:- Complaint against Veer Mahato, Arun Prasad and Naresh Sahani.

Respected Sir,

I, Rajveer Yadav, Son of Late Shivnath Yadav residing at Flat No. 601, Tower No. 6, HIG Building, Uttarayan, Matigara, Siliguri would like to bring the facts to your kind notice that above named three persons namely 1) Veer Mahato, Son of Sri Sukdeo Mahato, 2) Arun Prasad, father name not known and 3) Naresh Sahani, father name not known all are residing at Ward No. 43 of Siliguri Municipal Corporation, Prakash Nagar, Sevoke Road, Siliguri has been threatening and claiming extortion money very long time, but I ignored it. Last Week when my elder sister Asha Yadav walking in the street at about 09:00 P.M. in that moment the above named three persons trying to stop her forcefully and also trying to kidnaped her, when my elder shouted in that time they ran away after that incident the abovenamed person Veer Mahato called my elder sister Asha Yadav and started threatening her that "they will surely kidnap her next time than your brother will be paid the extortion money which we asked for". After that incident I told everything my cousin brothers about that matter then my cousin brothers went above named Veer Mahato house to meet his father and told every thing about his son then Veer Mahato father Sri Sukdeo Mahato assured mu cousin brother he never doing such thing next time. That time I thought the abovenamed persons deserved one chance so I did not lodged any complainant against them.

On 16/11/2022 the above named person Sri Veer Mahato sending abusive messages and called me several times after the continuously calling by veer mahato I pickup one call and he started threatening me that within a two days if I not paid the extortion money which they asked for they will brutally damage my family members and he also said that " if you have guts come to my father house" than I told him I never pay any amount of Extortion amount which they asked for then the above named Veer Mahato told me he will see me next time.

That on 18/11/2022 i.e. today my younger sister Miss Kajal Yadav cycling at about 9:30 P.M. to 10:00 P.M. to words my sisters house in that time when she exit from the HIG building at Uttarayan back gate in that moment my sister saw one white color Hyundai car waiting out side the building that the above named Veer Mahato stop my sister and forcing her to seat in the car and in that moment when she refused to seat in the car in that moment another two persons namely Arun MAhato and

Naresh Sahani came out the said car than they forcefully trying to get her in that car. In that moment my sister started shouting then one security guard of the building came towards them and then they ran away.

In that moment I very much worried about my family members so I and family members need police protection. That the above named Veer Mahato father is a Councilor of Ward No. 43 of Siliguri Municipal Corporation as because he doing this day by day and think himself above the law.

Sir, I run a Real estate business under the name and style of "Yadav Investments Private Limited" at the age of 22 years, that why they are very jealous of my early success. That why I ignored them very long time but now they started hurting my family members that why I very much worried about my family members.

So I pray that you take legal action against them and provide us police protection. I seek your help and request you to kindly register my F.I.R against them in the subject matter.
