I, **Sri. Sanjit Singha**, S/o. Sri. Prabir Kumar Singha, Hindu by religion, Indian by Nationality, resident of Thiknikata, P.O. Sushruta Nagar, P.S. Matigara, Dist. Darjeeling, Pin Code- 734012, West Bengal, India, Mobile No. 9832534203 would like request you to register a written complaint against 03 (three) nos. of land mafias - (1) **Sri. Niren Singha**, (2) **Sri. Siren Singha** both are the sons of Late. Haynath Singha, (3) **Sri. Dipen Singha** S/o. Sri. Siren Singha, all three are the resident of Khagaria Jote, Jugibhita, P.O. Nimai, Pin-734010, P.S. Matigara, District Darjeeling, Pin Code- 734010, West Bengal for forcefully acquiring my land, life threatening, for cheating, for forgery, deceit, loss, harm, injury & conspiracy.

I am the absolute owner of land measuring **11 Decimal** in L.R. Plot No. 205 & 206, being recorded in L.R Khatian No. 545, situated within Mouza JUGIBHITA, J.L. No. 58, under Matigara Police Station By the virtue of General power of attorney no. 429/2017 dated on 3 May 2017 being documented in Book no. IV volume nom 0403-2017 Page from 5996 to 6009 being no. 040300429 for the year 2017 executed by the recorded owner Sri. Gandhi Chetry , son of late Nath Bahadur Chetri @Nath B.D. Chetri.

That on **19/11/2022, at 1:00 PM**, I came to know from my local friends that two brothers Sri. Niren Singha & Sri. Siren Singha along with one Sri. Dipen Singha (Son of Sri. Siren Singha) has forcefully entered into my said land and started encroaching it forcefully by concrete construction without my consent. And on stopping them they got furious and attacked me on the spot. They have used slang languages on me and life threatened me and my family with fatal consequences if I try to stop them.

And for your kind information these land mafias do not possess any part or portion of land in L.R. Plot No. 205 situated within Mouza JUGIBHITA, J.L. No. 58, under Matigara Police Station and showing fabricated documents which does not have any legal values. Before there such interference I was enjoying the same peacefully.

Moreover these said land mafias has taken Rs. 10,00,000/- (Rupees Ten Lakh) only from one land broker and their partner Sri. Motilal Saibo, S/o. Sri. Fadra Saibo, Vill - Himul Bodo para, P.O. Nemai, under Matigara Police Station on account of sale of the said land and has allegedly entered into sale agreement by using my land documents paper of the said land which defines there intention to grab my said land and I believe this is a clear case of conspiracy, frogery and cheating.

It is serious case of conspiracy and illegal encroachment. I would like to request you to protect my land property from the said land mafias and am requesting you to take strong legal action against them so that they do not dare to touch anyone's recorded land property.

Therefore, I demand justice for the conspiracy, illegal encroachment, cheat, loss of money, deceit, forgery, harm and injury caused by **the said land mafias**. And I am requesting you to please register this FIR and take legal action against them.
