Dear Sir,

With due respect ,I, **SRI ABHIJIT ROY**, Son of Sri Ajoy Roy, resident of Nimajote, P.O.Nimai, P.S.Matigara, Dt. Darjeeling, would like to inform you that I have purchased land measuring about 7 decimal or 4.25 katha in Mouza Nimai, J.L no 57, in plot no.131(L.R), in khatian no 93(L.R), P.S. Maigara, Dt. Darjeeling from Smt Chakchoki Singh, wife of Late Bahar Singh & others which they have inherited from their husband Late Bahar Singh. since the date of purchase the entire land is in my possession as per my site plan which annexed to my sale deed and khatian has opened in my name vide khatian no.1887. Recently my uncle **Sri Nripen Roy**, ^{S/O- Chandan Roy} casting cloud in to my land for his wrongful gain. He also purchased land measuring about 10 decimal from one Kamalesh Chandra singha, Son of Sri Ratikanta Singha in the year 2014 at the time of registration major portion of land was not in his possession but he knowing fully purchased the same for his wrongful gain. Very recent he in collusion of some land grabbers wrongfully claiming our land as his own purchased land. I always told him I am possessing the land as per my site plan specified in my sale deed but he did not paid any heed to my request and two times he with his companions tried to enter in to my land for his ill motive but with the help of villegers I have restrained them. Today at afternoon when I was busy for my official work at siliguri the abovesaid Nripen Roy and his companion taking such opportunity entered in to my land for his same cause and when I was reported by the villagers it was to late to restrain them.

In this above circumstances I am requesting you to kindly investigate the above-said matter and take appropriate step against the abovesaid person as per the law and thus kind obilige me.
