Kamakhali P.O. Lushruta Nagar PS Matigara Dist. Durgajung
would like to bring your kind notice that today (20.11.2022)
at about 11:00 Am, near about 7 (seven) antisocial
out of which 3 (Three) are known to me namely
1. Sri Kaitash Sahani S/o Satish Sahani 2. Sri Sekhar
Das S/o Nimmat Das R/o Naukaghat near Kali Mandir
3. Shibu Singha S/o unknown R/o Medical College
near swimming pool and others (name is not known)
suddenly entered into my house and started measuring
my land with intention to possess my land forcefully
and unlawfully. When I asked them about their
identity they forcefully entered into my room and
started threatening me of dire consequences using
abusive and filthy languages.
When I showed for help and tried to escape
from the room they pushed me by my chest and
touch me inappropriately which outraged my modesty
they also molested me by tearing my cloth (sari) and
took my Silver chain which I was wearing at
