With the due Report, I Bikash Kumar Mandal of ward Shib Nagar
Dorjeeting more ward 46, would like to inform that on today's date
(20th of November) at 6:30pm some person gathered at the back
side of my house, and started breaking the boundary of my house
which was made of brick and cement (20 feet in size) forcefully
when my mother called me at 6:30pm regarding this issue they
had already broken the wall with their full strength, soon when I
came to know about this incident I called police but due to some
circumstances they were late, meanwhile some people entered my
house and assaulted my elder sister by holding her hands and stopped
her away, and drag her away while she was trying to stop them,
but she was hit by one person from behind with bamboo, & also
beaten her in chest & hand, she became unconscious, along with
they have robbed many things along with cash from the cupboard
of my room, later when the police arrived at the place, they all ran
away from the spot. My mother & elder sister was all home alone,
and there was nobody to help them out. The persons which were
involved in this matter were Rajesh Ray, Sambhu Sharma, Naresh
Ray, along with other persons in the group which were only recognizable
by face. The same said incident was also happened on (17th of
November when they tried to enter my house). So, hereby it's my
humble request to kindly look into this matter and give them
accurate punishment in this issue.
