Sir,

With due respect I the undersigned beg to inform you that my wife Dipali Dutta has committed suicide consuming poisonous substances and sleeping tablets on 11.11.2022 in the morning at my below mentioned address. It is to mention that I was not present at home at the time when she has committed suicide.

As soon as I got the information I went at my home at about 9 a.m. and immediately hospitalized her at Siliguri Sub-Divisional Hospital with the help of my neighbor and relatives at about 9.40 a.m. there the conducting doctor /Hospital in charge admitted her then and there.

At about 10.40 a.m. the Doctor who was in duty and or at charge declared her death. Thereafter I with my neighbor and relative did the entire procedure upto burning the dead body. Thereafter I came back at my house at night. I was mentally upset and became physically ill and could not lodge diary in time.

Today when I was searching the medicine box and found that there is a leaf of page written something when I go through the documents I came to know that it is suicidal note written by my wife herself where she has stated the reason of her committing suicide and also mentioned name of some person who has mentally and economically harassed her and induced her to commit suicide. It is to mention here that I used to run a Canteen at NJP Railway Station, at Platform No. I. and the below mentioned persons were my staff. Thereafter they have illegally occupied the canteen and as a result I became workless. On repeated request by me wife, they occasionally used to pay Rs. 100/- only per day. Since then I and my wife and son remained without having no food in most of the days. As a result my wife became frustrated for the future of my family. The person whose named is mentioned in the suicidal note is 1) **Nabendu Poddar (Madhu)**, Son of Late Nripen Poddar, resident of Bhaktinagar (West), near Sinha Villa, Ward No. 34 of Siliguri Municipal Corporation, Police Station Newjalpaiguri, District Jalpaiguri-734007, 2) **Parimal Dutta**, Son of Late Biswambar Dutta, resident of Bhaktinagar, Amrita Sishu Tirtha Sarani, Ward No. 35 of Siliguri Municipal Corporation, Police Station Newjalpaiguri, District Jalpaiguri-734007 and 3) **Dulal Sarkar**,

Son of Late Manaranjan Sarkar, resident of Bhaktinagar, Arabinda Society Road, Near BSNL Office, Ward No. 35 of Siliguri Municipal Corporation, Police Station Newjalpaiguri, District Jalpaiguri-734007

I therefore, fervently request you to accept the suicidal note which is recovered by me in presence of my son from my house and investigate the matter and also requesting you to take immediate legal action on the basis of the said suicidal note.
