Sir,

I, SI- Pradeep Diyai swas presently attached with NJP PS under your kind control beg to state that today i.e. on 16.11.2022 at 2215 hrs I received a secret source information that one person namely Badal Barman (58) s/o Lt. Suresh Barman of Ambikanagar, Sasan Busty, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Ambikanagar, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 746 dated 16.11.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for Ambikanagar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2225 hrs we arrived at Ambikanagar, and being identified by the source I held raid the shop where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I held raid but the accused person fled away from the spot. On search (i) 15 (Fifteen) Bottle of 60 Up Himalayan Gold country spirit containing 600 Ml. in each bottle (ii) 05 (Five) Bottle of Mcdowells No.- 1 Rum contining 180 Ml in each bottle (iii) 04 (Four) bottles of Kingfisher Strong permium Beer (each bottle containing 650 ml) I/D liquor recovered from their hotel. Accordingly, I seized the above noted I/D liquor after preparing proper seizure list. The whole process of search & seizure was made in between 2245 hrs to 2315

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused persons namely Badal Barman (58) s/o Lt. Suresh Barman of Ambikanagar, Sasan Busty, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
