Sub – FIR

Sir,

In producing herewith one (01) arrested accused person namely Mithun Sarkar (33 yrs), s/o – Lt. Mukul Sarkar of Ramanarayan Math, Ward No – 03, PS – Pradhan Nagar, Dist – Darjeeling (not verified) along with the following seized articles under seizure as per seizure list –

- (i) One (01) transparent plastic packet containing 264 gm. Said to be Brown Sugar which was kept in School bag as Exhibit "A".
- (ii) One (01) black and red color school bag.
- (iii) One (01) motor cycle bearing no – WB74BD/4848 (Bazaz Dominator 250 cc).
- (iv) One (01) Samsung black color android mobile with cover.

I, SI Swadesh Saha of Ambari Falakata Out Post under NJP PS, Siliguri Police Commissionerate do here by lodge this written complaint against the above noted person to the effect that today on 17/11/2022 at about 15:55 hrs received a specific source information that one person is coming from Fulbari side by a motor cycle having no WB 74BD/4848 with one black and red color school bag contained Brown Sugar ready for Supply'ng the said consignment of Brown Sugar to his designated customers for his wrongful gain at Nowapara Canal More area under Ambari Falakata Out Post, PS – NJP, Dist – Jalpaiguri. The matter was diarized vide Ambari Falakata OP GDE No-581, Dated – 17.11.2022. Accordingly I, informed the matter to O/C Ambari Falakata OP in writing a letter to him and expressed the entire information. As per kind direction myself along with SI P.R.Bhutia, C/393 – Shyamal Roy, C/824 – Styaban Das all of Ambari Falakata OP under NJP PS, Siliguri Police Commissionerate left for Nowapara Canal More under Ambari Falakata OP by Govt. Vehicle having no – WB 62A/7050 to verify the veracity of information vide Ambari Falakata OP GDE No 581, Dated – 17.11.2022 corresponding M.C.C No – 2619/2022, Dated – 17.11.2022.

At the time of departure from Ambari Falakata Out Post I, took envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 16:10 hrs we arrived at Nowapara Canal More under Ambari Falakata OP, PS – NJP, Dist – Jalpaiguri and called two (02) independent witnesses namely (i) Tarzan Roy, s/o – Narma Roy of 9 No Colony, PO – Kamarvita, PS – NJP, Dist – Jalpaiguri (ii) Prasan Kumar Roy, s/o – Lt. Harendra Nath Roy of Nowapara More, PS – NJP, Dist – Jalpaiguri who were present at there and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and as witnesses of entire process under relevant provision of law. After a long gap as identified by the source we found that one person was coming from Fulbari side towards Nowapara Canal More side with motor cycle having no WB 74BD/4848 which matched with the information in which one black and red color school bag was hanged on his back side. Accordingly on being asked the apprehended person disclosed his identity as Mithun Sarkar (33 yrs), s/o – Lt. Mukul Sarkar of Ramanarayan Math, Ward No – 03, PS – Pradhan Nagar, Dist – Darjeeling. After disclosing our identity we detained the above noted person with strong reason to believe that he has illegally possessing said to be Brown Sugar inside his school bag which he was carrying for supplying the same to his designated customers for his wrongful gain. On being asked he confessed that he has possessed the said to be Brown Sugar in his school bag for supplying the same to his designated customers as per requirement and he came there for transportation the same. I then gave him option whether he

wanted to be searched in presence of the Executive Magistrate or by any Gazette officer. Then he agreed to be searched by one of them. Further I served him a notice in accordance with the provision of law in this regards. I also offered the independence witnesses and the accused person to search our police party but they refused to search the Police Party. Then I sent C/824 – Satyaban Das with requisition to Special Executive Magistrate Sri M. Rahaman, ACP Investigation Unit & holding additional Charge of ACP, ICP, Fulbari, SPC for supervise the whole process of search & seizure. At 17:20 hrs returned at the spot with Sri M. Rahaman, ACP Investigation Unit & holding additional Charge Of ACP, ICP, Fulbari, SPC in uniform and disclose his identity to the detained person as well as witnesses. Under the supervision of Sri M. Rahaman, ACP Investigation Unit & holding additional Charge Of ACP, ICP, Fulbari, SPC and in presence of two independent witnesses searched was conducted of the detained person following all formalities keeping his decency. After conducting searched in his wearing apparels found nothing. Then conducting searched the black and red color School bag which he was carrying in his back side and found the above noted seized articles which was kept inside the said school bag. On demand in presence of the Spl. Executive Magistrate Sri M. Rahaman, ACP Investigation Unit & holding additional Charge Of ACP, ICP, Fulbari, SPC he failed to produced any valid documents in support of possessing said to be Brown Sugar.

Accordingly I weighted the said to be Brown Sugar by weighting instrument of Nowapara Canal More Grocery Shop of one namely Prasan Kumar Roy, s/o –Lt. Harendra Nath Roy of Nowapara More, PS – NJP, Dist – Jalpaiguri and found total 264 gm. Said to be Brown Sugar in one transparent plastic packet kept inside one black and red color school bag and marked as Exhibit" A". I also labeled and sealed all the articles in presence of The Spl. Executive Magistrate Sri M. Rahaman, ACP Investigation Unit & holding additional Charge Of ACP, ICP, Fulbari, SPC and independent witnesses and accused person. I then seized the above noted articles under proper seizure list and labeled duly signed by the above noted witnesses and the Spl. Executive Magistrate Sri M. Rahaman, ACP Investigation Unit & holding additional Charge Of ACP, ICP, Fulbari, SPC and acknowledge by the accused person. The seizure was made in between 17:25 hrs to 18:35 hrs. On further interrogation the apprehended person confessed in presence of The Spl. Executive Magistrate Sri M. Rahaman, ACP Investigation Unit & holding additional Charge Of ACP, ICP, Fulbari, SPC and other witnesses that he procured seized said to be Brown Sugar clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customers for his personal gain by illegal means. On interrogation he disclosed that he has been dealing in such business of selling the Brown Sugar illegally for last 01 year. Then I arrested the above noted accused person after observing all guidelines of Hon'ble Apex Court as well as after disclosing the cause of arrest and issued necessary memo of arrest. Thus arrested accused person named Mithun Sarkar (33 yrs), s/o – Lt. Mukul Sarkar of Ramanarayan Math, Ward No – 03, PS – Pradhan Nagar, Dist – Darjeeling as violated the terms and condition of Narcotic Drug for possessing Brown Sugar without any valid authority or license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Mithun Sarkar (33 yrs), s/o – Lt. Mukul Sarkar of Ramanarayan Math, Ward No – 03, PS – Pradhan Nagar, Dist – Darjeeling and arrange for its investigation.
