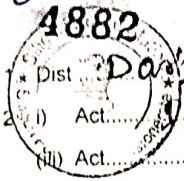

I shri Rajesh Kumar Yadav, s/o Lt. Banarasi Yadav, resident of Santoshi Nagar, Ganga Nagar, P.O Siliguri Bazar, P.S.-Siliguri, District-Darjeeling would like to inform you that I have purchased a small piece of baste land recorded and registered under sale deed no. 1821 of 2019 by the ADSR at Siliguri on 02-04-2019. The said land had a main gate and was duly bound by the brick wall and one convergated tin roofed house is also standing thereon. The land is situated at Ganga Nagar, Ward No: 05, Siliguri. On 20-11-2022 at about 07:30am few persons namely Shri Jitendar Prasad, s/o Bishwanath Prasad @ Kamkar, Shri Jogindar Prasad s/o Mahatan Prasad, Shri Gurjan Prasad s/o Shri Jogindar Prasad, Sushila Kumari w/o Jogindar Prasad, Murni Prasad d/o Bishwanath Prasad, Vishal Prasad s/o Murni Prasad, Manisha Prasad s/o Murni Prasad along with 3 to 4 people entered my landed property and broke down the pillars and the walls of the landed property. I was at my residence when I got this message from my locality people. That those accused persons entered into my private property only to extort money from me in order to sell my land without my intimation or authority. They criminally trespassed only by breaking the bricks of my wall.


