Sir,
In producing herewith one accused person namely Abhimunya Chhetri (30 yrs) S/o Arjun Chhetri of Jyoti Nagar, Ward No. 41, PS-Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1] Ten (10) Bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ML)
- 2] Six (06) Bottles of Oye Oye 70 up Country Spirit (Each bottle containing 300 ML)

I, SI Rantu Halder of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint to the effect that today on 20/11/2022 at 14.20 hrs while performing evening patrolling duty, received a source information that one person namely Abhimunya Chhetri (30 yrs) S/O Arjun Chhetri of Jyoti Nagar, Ward No. 41, PS-Bhaktinagar, Dist- Jalpaiguri is selling liquor at Jyoti Nagar more under Bhaktinagar PS without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/1431 Dilip Barman, CVF/-614 Sumit Roy, CVF /-935 Biplab Roy had been to the said place to verify the veracity of the information. On reaching there and as identified by the source it found that one person Abhimunya Chhetri was selling and storing liquor at Jyoti Nagar more under Bhaktinagar PS. Subsequently, I along with my force cordoned the place and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted place seized articles were found at that place. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 15.20 hrs to 15.50 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Abhimunya Chhetri (30 yrs) S/o Arjun Chhetri of Jyoti Nagar, Ward No. 41, PS-Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
