In producing herewith one accused person namely (1) Biswajit Roy (21), S/O- Late Giggs Police Commissionerals bazaar PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

 (1) 12 (Twelve) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 7.2 Liter & Λmount Rs 1440/-).

I ASI Inzamamul Hoque of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely(1) Biswajit Roy (21), 5/0- Late Giren Roy of Jaleshwari bazaar PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e 20.11.2022 I along with C/970 Bikash Roy and CV /909 Nityananda Roy while performing evening mobile van duty at Ashighar OP Jurisdiction, Vide Ashighar OP GDE no.582 Dated 20.11.2022 in course of which I received information from my source that one Biswajit Roy stored a huge numbers of bottles of liquor inside his house at Jaleshwari bazaar and used to sell to rhe local youth in higher rates. On the way I called two local person namely (1)) Sujit Roy (31) S/O Satish Roy of Ashighar Coloney PS Bhaktinager Dist. Jalpaiguri and (2) Ajay Sarkar (32) S/O Sunil Sarkar of Ghogomali PS Bhaktinagar Dist. jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Jaleshwari bazaar area as indicated by my source I held raid at the house Biswajit Roy at Jaleshwari bazaar . But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 21.05 hrs and 21.25 hrs on 20.11.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons (1) Biswajit Roy (21), S/O- Late Giren Roy of Jaleshwari bazaar PS Bhaktinagar Dist ,alpaiguri and arrange for its investigation.
