In producing herewith one accused person named Aklal singh @ Lal(38y/M), S/O- Madhab Singh of Samornagar, near Auto stand PS Pradhan Nagar, Dist Darjeeling under arrest along with following articles under proper seizure.

Eleven (11) bottles of Himalayan Gold 60 UP Country Spirit(Himalayan endeavour PVT LTD) each bottle containing 600 ml, Total 06 litr. 600ml. marked as exhibit A (Out of which one has been taken as sample for examination marked as exhibit A1)

I, ASI Ashit Singha of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Aklal singh @ Lal(38y/M), S/O- Madhab Singh of Samornagar, near Auto stand PS Pradhan Nagar, Dist Darjeeling to the effect that today on 20.11.2022 at 16.05 hrs received a source information that one person named is selling liquor in a shop situated at Regulated market under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with CV/128 Ajay Kr. Sahani, CV/223 Swapon Chetteri, CV/645 Pankaj Gupta(All of Pradhannagar Ps had been to Regulated market under Pradhan Nagar PS to verify the veracity of source information vide GDE no. 1327, Dt. 20.11.22. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of Police witnesses and arrested the above mentioned person named Aklal singh @ Lal(38y/M), S/O- Madhab Singh of Samornagar,near Auto stand PS Pradhan Nagar, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 16:25 hrs to 17.05 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Aklal singh @ Lal(38y/M), S/O- Madhab Singh of Samornagar, near Auto stand PS Pradhan Nagar, Dist Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
