With due regards I Sri Pradip Kumar Prasad, S/O Late Jagadish Prasad of Jogijhora Baraik, P.O: Ethelbari, P.S & Dist: Alipurduar, Pin: 785 204, would like to state that

I have purchased a land by virtue of a Deed of Conveyance, Executed by Sri Pawan Kumar Agarwala, Smt. Puspa Devi Agarwala, Sri Bejoy Kumar Singhania, Sri Murari Lal Singhania, Smt. Shyama Devi Agarwala Registered in the office of District Sub-Registrar Jalpaiguri Vide Deed No: I-3571 of 1990 dated 11/05/1990.

Land is situated within District Jalpaiguri, Pargana: Baikanthapur, Mouza: Dabgram, J.L No: 2, Sheet No: 8 (R.S), 24 (L.R), P.S: Rajganj (Now Bhaktinagar) under R.S Khatian No: 574 corresponding to L.R Khatian No: 430 R.S Plot No. 264 corresponding to L.R Plot No. 106, area of land purchased 8.25 Decimal or .0825 Acres or 5 Katha. After purchasing the said land from its recorded owner the I become the rightful owner-in-possession over the said plot of land having Lawful title, right, and absolute interest in respect of piece and parcel of land and also enjoying the peaceful possession of the said land free from all encumbrances for last 28 years.

In the year 2005 I have Mortgaged the Said Land with United Bank of India, Birpara Branch, Alipurduar Now Punjab National Bank, Birpara Branch, Alipurduar. Presently the Loan account is running and the original Deed is with the said Punjab National Bank, Birpara Branch, Alipurduar. Irrespective of the fact that I am the absolute owner having right, title, interest & possession over the land, some miscreants & antisocials of that locality tried to occupy the land by most illegal means. On several occasions they forcefully tried to take illegal possession of the same from my peaceful possession. On account of that I have informed the matter to the Bhaktinagar Police station on 06/04/2022 and on subsequent occasions but I was advised to take shelter of Civil Court for proper relief. On 11/08/2022 I came to know that the accused persons prepared a forged Deed vide Deed No: I-3006 of 2022 on 17/03/2022 from A.D.S.R Bhaktinagar by impersonating Santosh Pradhan (accused no: 5) as a Seller of the land and other accused persons were the Purchasers of the said land. They also try to manipulate R.O.R records from Rajganj B.L & L.R.O but after intervention of higher officials my R.O.R has been restored being L.R Khatun No: 430. Therefore by observing the present situation I filed a suit for Declaration, Permanent Injunction and Confirmation of Possession & Deed Cancellation before the Ld. Civil Judge Senior Division Jalpaiguri vide Title Suit No: 202/2022 & on being satisfied with documents presented and submitted before the Ld. Court....."LD. COURT HAS PASSED INJUNCTION ORDER RESTRAINING THE DEFENDANTS (ACCUSED) FROM CREATING ANY THIRD PARTY INTEREST OR ABSTAIN FROM CREATING ANY INTERFERENCE WITH THE PEACEFUL POSSESSION OF THE COMPLAINANT "

It is effective till 04/02/2023. But irrespective of the continuance of the order of Ld. Court the accused persons are trying to grab my land and sell it

to some third party and also take illegal possession of the Land. Most recently a few days ago I came to know that the accused persons in order to accomplish their ulterior and satanic motive most illegally by violating the mandates prescribed by the Ld. Court break the lock which was hanging in the main gate of the land & trying to make a temporary structure thereon and also painted the guard wall of the land in order to hide the writing in the wall "HYPOTHECATED TO PUNJAB NATIONAL BANK".

So therefore it is my humble request before the concerned authority to kindly look into this matter with utmost care & after proper investigation take action against the accused persons as per the provisions of law.
