With due respect, I would like to intimate you that huge quantity of ACSR Moose Aluminium conductor from behind of 400KV switchyard (Near pond) has been stolen. This AL conductor was spare and was stacked there for future use. Today, Morning, our security supervisor Mr. H B Gurung has intimated us about this incident. It is suspected that this conductor was stolen last night.

Similar type of theft incident happened in Sep-2022 and was intimated to your office vide letter dated 20.09.2022.

As this is huge national loss, it is hereby requested to please lodge one FIR against this incident and do needful for recovery of this theft material and also for deterrent for re-occurrence of similar incident in future.
