Sir,

With due respect, I am producing herewith one arrested accused person namely Mantu Sha (48) s/o Harow Sha of Sepaipara, Ps- New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 13 (Three) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)

I, ASI- Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 23.11.2022 at 2325 hrs I received a secret source information that one person namely Mantu Sha (48) s/o Harow Sha of Sepaipara, Ps- New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at Sepaipara area under NJP PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 1093 dated 24.11.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for Sepaipara area, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2345 hrs we arrived at Sepaipara, and being identified by the source I held raid the hoi where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his House since long for his illegal gain. On search the above noted I/D liquor recovered from his hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 0005 hrs to 0025 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Mantu Sha (48) s/o Harow Sha of Sepaipara, Ps- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
