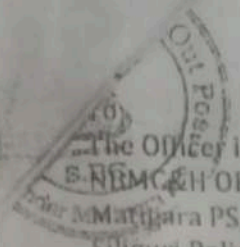

Sir,

In producing herewith one arrested accused person namely Shibu Das (M-30) S/O-Lt Gouranga Das of Kawakhali Near Deshpremi Kishar Sangha Club PO Sushruta Nagar, Dist Darjeeling along with seized articles (i) 12 (Twelve) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL N-) 01

I, SI Arindam Banerjee of North Bengal Medical College & Hospital OP under Matigara PS SPC do hereby lodge a written complaint against the above noted accused person to the effect that today on 24/11/2022 at 17:05 hrs during evening RT mobile duty I received secret source information that, one person is carrying huge quantity of country spirit through Ashian Highway-2, near Medical More. Accordingly I informed the information to OC NBMC&H OP and as per his direction I along with C/340 Proanab Adhikary and C/1071 Sumit Sherpa left for PO to workout the information. On arrival at Medical More near Radha Gobinda More at 17:15 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 12 (Twelve) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag. On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Kawakhali and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 12 (Twelve) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 17:25 hrs to 17:35 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1440/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Shibu Das (M-30) S/O-Lt Gouranga Das of Kawakhali Near Deshpremi Kishar Sangha Club PO Sushruta Nagar, Dist Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
