In producing herewith one accused person named Roghunath Das (60), S/O-Lt. Khokaram Das of Khudirampally, Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling along with following articles under proper seizure.

- 1) 15 (Fifteen) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml, Total 09 liters, value Rs.120X15=Rs1800/-, and marked as 'exhibit -A'.
- 2) 01(one) bottle Himalayan Gold 60 UP Country Spirit, containing 600 ml which was randomly taken out from Exhibit -A as sample for examination and marked as "Exhibit-A-1"
- 3) 10 (Ten) bottle of Mc Dowell's No-1 CELEBRATION MATURED XXX RUM each bottle containing 180 ml, Total 1.8 liters, value Rs.140X10=Rs1400/-, and marked as 'Exhibit -B'.
- 4) 01(one) bottle of Mc Dowell's No-1 CELEBRATION MATURED XXX RUM containing 180 ml which was randomly taken out from Exhibit -B as sample for examination and marked as "Exhibit B-1".

I, ASI Tapan Das presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted arrested accused person that today (28.11.2022) at 19.15hrs onwards acting on source information, myself along with, others force and officers had been to Paribahannagar under Matigara PS area and found that the aforesaid person had been selling illegal liquor to the common customers at his hotel at Paribahannagar under Matigara PS. Then I cordoned the place with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he used to sell illegal liquor at this place for his wrongful gain. On being search in presence of available witnesses the above noted seized articles are found inside a bag from his conscious possession. Subsequently, on demand he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of available witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person under proper memo of arrest and observing all the formalities of arrest. While at the time of cordoning off the place, the persons who were having liquor at that place manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 20.05 hrs. to 20.45 hrs.

Therefore, I pray before your good self that a specific case against the above noted accused person named Roghunath Das(60), S/O-Lt. Khokaram Das of Khudirampally, Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
