With due respect, I, **SRI RANJAN BASAK**, Son of Sri Shambhu Nath Basak, Resident of 14/4, Dr. B.C. Roy Sarani, East Vivekananda Pally, Ward No. 38 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734006, would like to lodge this written complaint to the effect that **SRI KANCHAN BASAK**, Son of Sri Shambhu Nath Basak is my elder brother who is an Employee of the State Government and presently, posted at the Office of the B.L. & L.R.O., Siliguri.

Sir, on 20.11.2022 at about 06.00 P.M., my said elder brother Sri Kanchan Basak left the house with his Motor Cycle (I Smart) bearing Registration No. WB-74-AD-9586, accompanied with his daughter Miss. Shamika Basak, in order to drop her in her Tuition Class at Deshbandhu Para, Siliguri and at about 06.15 P.M., when they reached at Hakim Para, Near Arunaday Sangha, Ward No. 16 of S.M.C., Under Siliguri Police Station, at that relevant point of time, one Two Wheeler Vehicle bearing Registration No. **WB-74-BE-7895** (Royal Enfield Classic - 350 EFI) which was coming from the left side road of my brother's vehicle with a very high speed and negligent manner and hit and dashed the vehicle of my brother forcefully for which, my brother and his daughter had fallen down on the road and received severe injury on their person and both of them became senseless and immediately after the said incident, some local people gathered there and recovered my brother and his daughter and took them at Siliguri District Hospital in a critical condition and thereafter, the local people informed us about the said incident and immediately after hearing the same, I along with our family members went to Siliguri District Hospital where, after some preliminary treatment, the daughter of my brother was discharged but considering the critical condition of my brother, we shifted him at Anandaloke Nursing Home, Siliguri for his better treatment and after medical examination, the Doctor informed us that due to the said accident, they have made two numbers of surgery in his body and an organ near the stomach which control the quality of the blood, has removed from his body

and his health condition is deteriorating day by day and still now, he is undergoing treatment at Anandaloke Nursing Home, Siliguri, in critical condition and huge amount of money has already been incurred for the sake of his treatment. Sir, the local peoples including my brother and his daughter told us that the said accident occurred due to the rash and negligent driving of the driver of the said offending Two Wheeler Vehicle bearing Registration No. **WB-74-BE-7895** (Royal Enfield Classic - 350 EFI). Sir, as I along with my other family members were remain busy for the purpose of the treatment of my brother, some delay has been caused for lodging this written complaint and the same may be condoned.

I, therefore, request you to kindly investigate into the matter properly and please take necessary legal action against the driver of the said offending vehicle bearing Registration No. **WB-74-BE-7895** (Royal Enfield Classic - 350 EFI) as per the provisions of law and obliged thereby.
