① That Taree Yadav who is my near
granddaughter aged about 14 years has
been missing from her residential address
at Santoshinagar, P.S. Siliguri, Dist: Dajed
since the morning of 25/11/2022 at around
6:30 am in the morning.

② That my granddaughter left from home
at around 6:30 am in the morning in
her full school uniform and told the
family members that she is going to
school.

⑧ That when my granddaughter did not return back from school by 11:50 am my son and myself went away in searching for my granddaughter. On finding out about her whereabouts we came to know from one of our neighbours that a boy named Arun Paswan & Jagan Paswan and Chakia Devi, who was residing near my house in the above mentioned address had forcefully taken away my granddaughter against her will and had put her into a bus which travelled from Siliguri to Baishali at Bihar.

That on further enquiry I also found out that one boy named Gopal Saha and Vijay Mehto who were working together with Arun Paswan and were also residing with him, had helped the said Arun Paswan in forcefully kidnapping my minor granddaughter away against her will and without any information to the guardians.

⑤ That after such information I went to said Areen Paswan at Digdha Falēhpur, P.O. Minagar, P.S. Baliganon, Dist: Vaishali, Bihar to get back my minor granddaughter. On reaching there the parents of Areen Paswan namely Jagan Paswan and Chaklia Devi along with his brother Shukla Paswan started to beat me with fist and blows and also threatened me of dire consequences if I go and file any complaint against them. On requesting them to kindly return back my granddaughter who was present at their house at that moment. The family directly refused and forcefully threw me out of their house.
