Respected Sir,

With due respect I, Nirmal Sharma, S/O - Late Sushanta Sharma, presently resident at Sahudangi, Baniyapara, P.O - Sahudangi Hat, P.S -NJP, Dist - Jalpaiguri, permanent resident of Burir Pat, Khagra Bari, P.O. - Khagra Bari, P.S. - Pundibari, Dist. - Cooch Bihar, 736118, beg to inform you that I am an employee of "SITI CABLE" and our office situated at Ambari Post Office More and since long I use to work as a worker to connect wire of the set of Boxes of old connections and also connect the new connections of the new customers.

It is pertinent to mention here that it is a part of our business that some of our customers leave SITI Cable and some new customers join with SITI Cable from the other Cable Service operator's and it depends on the wish / will of the customers and as per our business policy if any customer willfully wants to be new customers of "SITI CABLE" in that event we give new connection to those customers and also give service to them.

It is very unfortunate that today 27/11/2022 morning at about 9.30 am when I was sitting in front of Pan Shop of Rama Kant near Ambari Bot tola Rail Gate at that time one Raja Das Gupta, S/O - not Known, of Ambari Station, P.O. - Kamarvita, P.S. - NJP, Dist. - Jalpaiguri, suddenly came to me and all on a sudden started to assault me mercilessly and he slapped me and pulled me by catching the Kolar of my Shirt and beat me and when I fell down on the ground then he kick me roughly with a motive to kill me and as that was a crowdly place so local people came forward to save my life and obstruct said Raja Das Gupta for stop assaulting me and by this way I somehow save my life from said Raja Das Gupta and there was heavy bleeding from my mouth and nose and subsequently I was taken to North Bengal Medical Collage & Hospital and I treated there.

It is to be noted here that said Raja Das Gupta is CCN cable operator in that locality and he has a rivalry regarding his cable business with SITI Cable authority and as I am one of the employee of the SITI cable authority for this reason said Raja Das Gupta suddenly attacked upon me with a very planned way with a motive to kill me and I came to know that previously said Raja Dasgupta Attacked to the house of Satya Ranjan Dhar, the owner of SITI Cable on 03/12/2021 with his ill motive.

It is pertinent to mention here that Raja Das Gupta is a dangerous person and he threatened me with a dire consequences that he will ruin my life and in future he will attack upon me whenever he will get me alone and he also threatened me that we can do nothing against him as he has political holdings and he is the only Don in our locality and he also threatened me that he will implicate my name in some false cases.

It is therefore prayed that I am in great fear and anxiety from the activities of the above named Raja Das Gupta and you will be kind enough to enquire into the matter immediately and further be pleased to take appropriate legal action against above named Culprit to save my life for ends of justice.
