I, Smt. Manju Roy @ Manju Dakua, wife of Sri Shibu Roy, presently residing at Sitalapara, Ward No. 31 of SAC, PS- NJP, Dist- Jalpaiguri, do hereby beg to inform you the following facts :-

1. That I am married with Shibu Roy, S/o Mahendra Roy on 04/12/2017 as per Hindu rites and customs by organizing ceremony and my marriage is social marriage in presence of friend, relatives and para people and after marriage I am residing with my husband and his family members at my matrimonial house at Sitalapara, Ward No. 31 of SAC, PS- NJP, Dist- Jalpaiguri.
2. That in the said marriage my parent give dowry as per demand of my husband and his family members of Rs. 2 Lakhs by cash, gold jewellery and other household articles.
3. That after marriage I reside and cohabit together as husband and wife at my matrimonial houses.
4. That since after my marriage when I started to reside at my matrimonial house I am shocked to know that my husband have illegal sexual relation with one girl namely Monica Roy and this matter is also known to the other family members of my husband.
5. That on the matter of aforesaid facts about my husband, my in-laws family members namely i) Shibu Roy (Husband), ii) Mahendra Roy, S/o not known (father-in-law), iii) Smt. Gita Roy, W/o Mahendra Roy (mother-in-law), iv) Smt. Lakmi Roy, W/o Banga Roy (sister-in-law) v) Smt. Sataewati Roy, W/o Karal Barman (sister-in-law) all are resident of Sitalapara, Ward No. 31 of SAC, PS- NJP, Dist- Jalpaiguri started to torture and abuse me with

mentally and physically and the abovenamed in-laws family members threatens me to kill if I do not adjust with my husband and force me to accept the illegal sexual relation of my husband.

6. That my husband came house in late night in intoxicate mood and assault me by fist and blows and by kicks and several time the other family members assault me mercilessly and also force me to leave my matrimonial house.
7. That my now my husband have illegal sexual relation with another girl and on the said issue the in-laws family member torture me physically and always force me to leave house.
8. That there is a meeting was held regarding the atoresa fact but the all are in vain.
9. That on 28/11/2022 at about 8.00 PM my husband and other family members assault me by fist and blows and by kicks and beated me marcilessly and when I cried for help the neighbour came and save me from their hand and thereafter treated with doctor at S D Hospital, Siliguri.
10. That I and very unsafe and my life is in risk and I want my safety to save my life.

So, I therefore kindly request you to investigate the matter and take necessary action against the above named persons.
