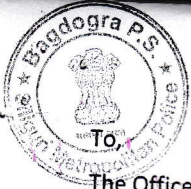

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Sachin Lama (42) s/o Lt. Tshring Lama of Panighata road, Upper Bagdogra PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Fifteen (15) sealed Bottles of Kingfisher strong premium beer, , each bottle 650 ml , Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1
2. Twelve (12) sealed Bottles of Tuborg strong premium beer, each bottle 650 ml , Marked as exhibit-B in which 01 bottle taken as sample for examination exhibit-B1
3. Four (04) sealed Bottles of Emboss Fine Whisky , each bottle 750 ml , Marked as exhibit C in which 01 bottle taken as sample marked as Exhibit-C1
4. Five (05) sealed Bottles of Mc. Dowels No.1 Celebration RUM, each bottle 180 ml each Marked as exhibit -D in which 01 bottle taken as sample for examination exhibit-D1
5. Five (05) sealed Bottles of Mc. Dowels No.1 Superior Whisky, each bottle 180 ml each Marked as exhibit -E in which 01 bottle taken as sample for examination exhibit-E1
6. Twelve (12) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml , Marked as exhibit-F in which 01 bottles taken as sample for examination exhibit-F1

I am submitting a written complaint against the above noted accused person to the effect that today on 01.12.22 at 17-15 hrs received a secret source of information that one person was selling Id Liquor illegally from his house at Panighata road, Upper Bagdogra to its customers without any valid license. Accordingly I informed the duty officer of Bagdogra PS and O.C. Bagdogra PS and as per his instruction myself along with ASI Khagen Barman , C/1008 Kanak Roy, CV- 386 Kishor Hawider VP-01 Ansalam Kujur left for Panighata road, Upper Bagdogra to verify the veracity of information which diarised vide Bagdogra PS GDE No. 35 dt. 01.12.22. On arrival at the spot at 17-45 hrs it was found that one person mentioned above was selling liquor illegally from his house at Panighata road, Upper Bagdogra under PS Bagdogra to his designated customers to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above. Thereafter in the presence of disinterest witnesses namely (1) Md Ramzan (24) s/o Lt. Md Fakira of Panighata road , Upper Bagdogra PS Bagdogra Dist. Darjeeling and (2) Kundan Kumar (23) s/o Prem Lal routh of Jyotinagar PS Bagdogra Dist. Darjeeling I alongwith force recovered 1. Fifteen (15) sealed Bottles of Kingfisher strong premium beer, , each bottle 650 ml (2) Twelve (12) sealed Bottles of Tuborg strong premium beer, each bottle 650 ml (3) Four (04) sealed Bottles of Emboss Fine Whisky , each bottle 750 ml , (4) Five (05) sealed Bottles of Mc. Dowels No.1 Celebration RUM, each bottle 180 ml (5) Five (05) sealed Bottles of Mc. Dowels No.1 Superior Whisky, each bottle 180 ml each (6) Twelve (12) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml from his house at Panighata road, Upper Bagdogra under PS Bagdogra from the possession of the apprehended person and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 18-25 hrs and 19-45 hrs (seizure Total approx 29.5 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sachin Lama (42) s/o Lt. Tshring Lama of Panighata road, Upper Bagdogra PS Bagdogra Dist. Darjeeling and arrange for its investigation.
