- 3) That yesterday around 10.00 P.M they came to my home and tortured me, harassed me physically assaulted me and used many slang languages.

- 3) That they came and broke the locker and took everything especially the Jewellery Box which was given by my father in my and sister (Momina Begum) which who is present by my side.

Raja (Brother-in-law) 5) Minar Begum (Mother-in-law) 6) Manju Khatoon (sister-in-law). on 27/11/22 at 9 P.M. resident of they belongs to resident at Above Ambedkar Colony, and in P.S. Poard harr Nagar Siliguri
- 7) That my ① mother in law (Mine Begum) and my ② sister in law (Manju Khatoon) resident of South Ambedkar Colony and other ③ sister-in-law (resident of Salbari at husband's home, and always they come and always torture me and beat me with sharp objects.
